# Lawyer/lobbyist from Iowa slain in Minnesota

The estranged husband of a woman also shot to death is a suspect in the case.

E. Kevin Kelly of Johnston, a lawyer and lobbyist who served eight years in the Iowa Legislature in the 1970s, was found shot to death along with a female friend in a posh suburb of Minneapolis, friends said Friday.

Kelly's body was found with that of Barbara Lund, 55, the estranged wife of businessman Russell T. Lund Jr., 59, whose family owns a chain of grocery stores in the Twin Cities area, according to Kelly's friends in the Des Moines area.

The Lunds reportedly had been going through a bitter divorce in proceedings that began three or four years ago.

### Anonymous Call

The bodies were found by police at Russell Lund's residence in suburban Minnetonka.

Minnetonka police told reporters Friday that they received an anonymous call about 7 p.m. Thursday informing them that two deaths may have occurred at 2301 Sherwood Hills Road in Minnetonka. Investigators entered the home at about 11 p.m. and found the bodies.

Russell Lund Jr. is a suspect in the slayings, police said. He was undergoing psychiatric care Friday night, police said. Arrangements were being made to question him.

The slayings occurred in a secluded modern brick house in a wealthy

neighborhood. The area was cordoned off by police Friday.


### Sioux City Native

Kelly, 49, was a Sioux City native who served two years in the Iowa House and six years in the Iowa Senate as a Republican from 1971 to 1978, when he decided not to seek re-election. He was an assistant Woodbury County attorney from 1968 to 1971, and from 1970 to 1974 was state chairman of the Iowa Young Republicans.

In recent years, Kelly was a well-known and well-liked lobbyist at the Iowa Statehouse. He switched party affiliation in 1988 to become a Democrat.

Kelly met Barbara Lund in Decem-

said John Roehrick, head of the Iowa Democratic Party.

"This shows Iowa is important to him. He believes he needs Iowa to put together a winning combination," Roehrick said.

Republicans were more inclined to attribute the warm welcome to Iowa hospitality than to a groundswell of support for Clinton. Said Oman, "How many were dedicated Clinton supporters and how many were curious, hospitable Iowans wanting to see a candidate in the flesh and blood remains to be seen."

Rep. Darrell Hanson, a Republican legislator from Manchester, was apparently one of the few people in that community who missed Clinton's visit Thursday, because he was returning from vacation. "Everyone has said, 'Well, did you go out and see Clinton?' I think we've heard that from everybody," he said.

Political analyst Dennis Goldford, a Drake University associate professor, said the bus tour — Clinton's second — was definitely a plus for Clinton, although it's much too early in the race for the candidate to be taking victory laps.

"It was a positive thing for him. Political campaigns normally are wholesale operations where you deal with masses of people. This was a retail operation where you're dealing with smaller groups of people and meeting them face to face," Goldford said.

Oman said there was plenty of time for President Bush to win converts.

"We hope to have and need to have a good convention... in Texas, and I believe we will," he said. "That will give the president his day in the sun. He has not had his day in the sun." The Republican convention will begin Aug. 17 in Houston.

Neighbors told a Minneapolis newspaper that Russell Lund was a reclusive man who seldom mixed with other residents.

"He didn't look like a rich guy at all," one neighbor told the Star Tribune. "His clothes were kind of strange, like brown and raggedy. You would wave to him and he wouldn't wave back."

### Attended Iowa Wedding

Kelly and Barbara Lund attended a wedding in Iowa last week, friends told the Star Tribune.

Kelly told friends in Des Moines earlier this week that he would be going to the Twin Cities to promote one of his new business ventures, Active Times Magazine, a publication dealing with the lifestyles of people age 50 and older.

The Aspen-based publication is designed to be distributed as an insert to newspapers, and Kelly said he wanted to talk to Twin Cities newspaper executives, friends said.

Records show that during the past legislative session, Kelly's clients included AT&T, the Iowa Defense Counsel Association, Chicago Northwestern Corp., and the Iowa Association of Cemeteries. Friends said he had been active in Ducks Unlimited and had served as a national trustee of the wildlife organization.

Kelly was an avid competitive swimmer, and in 1991 participated with Des Moines banker J.C. "Buz"

Brenton in a 28½-mile race around Manhattan. Kelly's time of nearly eight hours was 17th best among 40 participants in the race, and the best time in his age group.

### Two Daughters

Kelly is survived by two daughters, both in their 20s. Tracy Ann, who was living with her father for the summer, is a student at Iowa State University, friends said. An older sister, Timory Lynn, lives in the East, friends said.

Kelly was one of eight children in a prominent Sioux City family that once owned the now-defunct Sioux City Tribune. Kelly's father and an uncle sold the paper to the Perkins family, the Sioux City Journal's owners.

"He was a popular and respected former member of our community," said Wiley Mayne of Sioux City, a former Republican member of the U.S. House. Kelly represented the city of Sioux City as a lobbyist, and Mayne said he kept up ties with people there.

### "Good Citizen"

Although he changed party registration, Kelly was a friend and

strong supporter of U.S. Rep. Fred Grandy, a Republican who also was reared in Sioux City.

Des Moines lawyer Keith Uhl, who first became acquainted with Kelly at the University of South Dakota, called Kelly "a super, all-right guy."

"He was always a straight shooter and a good citizen of Iowa," said Uhl.

He was a graduate of Sioux City Central High School, received a bachelor's degree from Gonzaga University in Spokane, Wash., and was a 1968 graduate of South Dakota Law School.

"This is a shocker," said Lee Dallager of Des Moines, a longtime friend of Kelly. "I just saw Kevin walking across the street the other day. Kevin was a good guy."

David Archie of Des Moines, publisher of The Iowan magazine, said he last talked to Kelly on Monday about his pending trip and some business matters. Archie said he'll remember Kelly for his diverse range of interests — music and ballet, athletics and conservation causes.

### Competitive Swimmer

Ed Campbell of Des Moines, a veteran legislative lobbyist, said he had known Kelly for more than 20 years. "He was a hell of a good guy. He was an excellent swimmer and had swam at tournaments around the Midwest."

Frank Burnette, a Des Moines lawyer, said he and lawyer Burns Davidson had shared office space with Kelly since January.

"Kevin was an excellent lawyer and a fine athlete. I knew him more from the YMCA and his mastery of swimming than anything else. He swam at noon frequently and I ran at noon."

Authorities said Friday the investigation was continuing. Both victims died of multiple gunshot wounds, according to the Hennepin County medical examiner's office.

Kelly's mother, Dorothy Kelly, continues to live in Sioux City. A family spokeswoman said no funeral arrangements had been made by late Friday.

Knutson admitted the group was at least partly responsible for sexual misconduct at the Las Vegas convention, where women, some of whom were Navy officers, were groped, fondled and sexually assaulted by drunken Navy aviators in a hotel hallway.

## Senator: Ex-CIA man lied about Secord ties

**Washington, D.C. (AP)** — Ex-CIA spymaster Clair George "purposefully, willfully" hid the fact he had met arms middleman Richard Secord from senators investigating the Iran-Contra affair, a former senator charged Friday.

"When the question came up... he knew it all along. He never met Secord, he says, but we know he did," former Sen. Thomas Eagleton, D-Mo., testified during George's criminal trial.

George, the former chief of all CIA overseas spy operations, is charged with lying when he said he had never met Secord.

## Daunted, astronauts prepare to come home

**Cape Canaveral, Fla. (AP)** — Atlantis' disheartened astronauts packed up Friday after a vexing week in which they failed to accomplish their main goal — reeling out a satellite on 12½ miles of tether.

A jammed line forced the seven astronauts to reel in the satellite from a distance of just 750 feet Wednesday.

# Police query husband of slain woman

**Minnetonka, Minn.** — Russell T. Lund Jr. went to police with his attorney Saturday, two days after his estranged wife, Barbara, and former Iowa lawmaker E. Kevin Kelly were found shot to death at Lund's home in this posh Twin Cities suburb.



No charges have been filed, but Lund remains the pri-

mary suspect in the slayings, Police Chief Richard Setter said Saturday.

Minnetonka police were releasing little other information about the questioning of Lund.

### High-Powered Lawyer

Some Twin Cities media reported that Lund had checked into the psychiatric unit of a hospital under an assumed name Friday, but authorities wouldn't confirm those reports.

"He was brought to our office. We do not know where he was staying or where he will be staying," said Lt. Mike Olson of the Min-

netonka Police Department.

Lund is being represented by Joseph Friedman, a well-known Minneapolis defense lawyer.

"He takes the big ones," Olson said of Friedman.

Investigators will meet with the Hennepin County attorney's office Monday to review the case.

Olson wouldn't say whether a weapon had been recovered or what type of gun had been used. He also wouldn't comment on where the bodies had been found in the house.

### Vehicle Sought

The Associated Press said Saturday that police are still looking for a 1987 Chevrolet Suburban with several radio antennas.

Olson said authorities also want to talk to Kelly's daughters, who are believed to be in the Minneapolis area making funeral arrangements.

Kelly, of Johnston, told friends in Des Moines last week that he would be going to the Twin Cities to promote one of his new business ventures, Active Times Magazine, a publication dealing with the lifestyle of people age 50 and older.

He had said he hoped to meet with newspaper executives in the area about the publication.

Authorities also want to find out why Barbara Lund and Kelly were at Russell Lund's residence.

"That's what we're looking at. Was it just happenstance that she was there? Or was it a prearranged meeting?" Olson said.

### Woman Lived in Orono

Barbara Lund was living in the family home in Orono, Minn., an exclusive suburb in the western Twin Cities area. She also had possession of the family home in Aspen, Colo., where she had been spending much of her time and where she and Kelly first met in 1990.

Friends told the Associated Press that she typically stayed at the Orono home, but it was not unusual for her to visit the home in Minnetonka, an isolated house on top of a ridge that neighbors said Russell Lund chose for the clear reception it provided for his hobby in amateur radio, friends said.

The Minnetonka home was equipped with a security system, but it was not on when police broke day night. There were no signs of

The \$385,000 home in Minnetonka is in a secluded and wooded area designed to ensure privacy. It is difficult to see the house from the street, although a 36-foot-long motor home that authorities say Russell Lund Jr. would take on extended trips was visible in the driveway.

Lund's father and namesake founded the Lunds chain of upscale grocery stores. Russell Lund Jr. was not active in running the company, leaving that to his son from his first marriage, Russell Lund III.

Barbara Lund was a skiing enthusiast who tried out for the Olympic team several years ago. She was a successful real estate agent and a former Miss Minneapolis. She served for several years as president of the Minnetonka Art Center. She was originally from Duluth.

Kelly, 49, was a Sioux City native who served two years in the Iowa House and six years in the Iowa Senate as a Republican from 1971 to 1978. Recently, he has been a lobbyist at the Statehouse for several interests.



During the service, Watson said, "I went from a feeling of horror to a feeling of sadness."

### Iowa Memorial Service

A memorial service for Kelly, 49, will be at 11 a.m. today at Blessed Sacrament Catholic Church in Sioux City.

John Kelly Jr. said his brother's car was being repaired while his brother was in the Twin Cities last week and he apparently had been riding in Barbara Lund's car. Lund's light-blue Mercedes was towed from the driveway of Russell Lund's "Ridgetop" home last Friday.

John Kelly Jr. said his brother intended to pick up his car and return to the Des Moines area and Barbara Lund planned to catch an airplane for Aspen. But they went to the home of Russell Lund before their departure.

### Shot Repeatedly

Officials say Kevin Kelly and Barbara Lund were shot repeatedly, but they would not say what type of firearm was used. Asked about the location of the gunshot wounds, a spokesman for the Hennepin County medical examiner's office said the wounds were "scattered."

Russell Lund has been questioned by police in the presence of his lawyer but later was released without charges. He had been separated from Barbara Lund about three years.

Russell Lund's father died earlier this year. Police say they are interested in any possible "dollars and cents" case and they have already immediately sought a will or divorce information.

Minnetonka police said they knew who reported the homicides but would not disclose that identity.

The police were first alerted to the homicides about 7 p.m. Thursday. A spokesman for the medical examiner's office placed the time of death at several hours before the bodies were discovered at 11 p.m. Thursday.

When police went to the house at 7 p.m. it was locked and they could not find any evidence of an intrusion or crime. But, acting on information from the telephone call, authorities obtained a search warrant and entered the home four hours later and discovered the bodies.

After enduring year from her husband, Darl stabbed the man to death with a butcher knife when he threatened to kill her. Her defense lawyer said Tuesday she saved her life.

"She did what she had to do to save her life," James Williams said in a Polk County jury verdict that sentenced Daniels, 29, to life in prison.

But Assistant Polk County Attorney Nan Horvat said Tuesday night of May 26, 1991, she was sentenced "as the judge, the jury and the executioner."

"She will ask you to let her out of this case to give her a chance to live," Horvat told the jury.

Daniels is charged with first-degree murder in the death of her common-law husband Williams, 37, who was shot once in the heart. If convicted on that charge, she faces a life in prison.

## Daughter's Testimony

Daniels' 8-year-old daughter, Marva, took the witness stand Tuesday and testified she told a hushed courtroom she had seen her father killed at the family's apartment at 624 Walker St. the night of her mother's death.

The presence of a child in the courtroom seemed jarring in contrast to the panoramic view of violence presented in the courtroom. The child was held by her mother, who lives, when she walked into the courtroom.

# Police say families uncooperative

**A Kelly family member says there is no conspiracy, just a desire to get through memorial services.**

Relatives of the two people shot to death at a posh suburban home near the Twin Cities last week aren't cooperating with the investigation, police said Tuesday.

Richard Setter, chief of the Minnetonka, Minn., police department, said there appears to be a systematic effort on the part of family members of Russell T. Lund Jr., Barbara Lund and Kevin Kelly not to speak with the police department.

"It's very bizarre," Setter said.

A Kelly family member says, however, there is no conspiracy to avoid police, just a desire to get through memorial services and initial stages of the grieving process.

Barbara Lund, 55, of Orono, Minn., and her boyfriend, Kevin Kelly, 49, of Johnston, Ia., were found dead in the home of her estranged husband Russell Lund, in Minnetonka, Minn., last Thursday. The Lunds were in the process of a divorce and had been separated for three years.

Lund, the primary suspect in the homicides, is reported to have checked into a hospital in the Twin Cities area and Minnetonka police have been told they'll need a court order just to view the admission records.

Asked about the charge that family members had been avoiding police, Kevin Kelly's brother, John Kelly Jr. of Sioux City, said: "I have to believe they are talking about

Kevin's daughters." They are Timothy Lynn Kelly of Hot Springs, N.C., and Tracy Ann Kelly of Sioux City.

"To my knowledge I am the only one in the Kelly family that Minnetonka police have talked to," he said Tuesday. "I talked to the police on the phone for a half-hour Monday



## Families Were Friendly

# Police await key detail in slaying of lawyer

**At issue is when a suspect in the killings checked into a Minneapolis hospital.**

Law officers in Minnesota say they may soon know when the suspect in the homicide of a Johnston, Ia., lawyer and his Minnesota girlfriend checked into a Minneapolis hospital.

Russell Thomas Lund Jr. is believed to have been admitted to the Fairview Riverside Medical Center in Minneapolis about the time the bodies of Kevin Kelly of Johnston and Barbara Lund of Orono, Minn., were found in Russell Lund's Minnetonka, Minn., residence on Aug. 6.

Officers served a search warrant at the medical center on Thursday for sealed information. The records were given to police and will be turned over to Judge Andrew W. Danielson for private review. He will determine what information will be made available.

Both defense lawyers and prosecutors were expected to meet with the judge at the time of the review.

Police want to know whether Russell Lund, the key suspect in the case, was a patient at the hospital at the time of the slayings or whether

he checked in after they occurred.

Police also want to know whether he was allowed to check in and out of the facility, and if so, whether records were kept.

The Lunds were in the process of getting a divorce when Barbara Lund and Kelly were shot to death at Russell Lund's home. Russell Lund had lived alone at the residence for about three years, and his estranged wife lived in Orono and at a residence in Aspen, Colo.

Also Thursday, Minnetonka police said that a handgun, which was recovered in the case and listed as a possible murder weapon, has been traced to Russell Lund. Police added, however, that the firearm has not been established as the murder weapon.

Minnetonka Police Chief Richard Setter said in a press release Thursday that both Kelly and Lund family members have cooperated in the investigation. Setter criticized family members earlier, saying they had refused requests for interviews.

# Three die in car accident

# Lund lawyers knew of double homicide hours before police

**Family members** say one victim's husband may have been in the house with the bodies after the shootings.

Lawyers for supermarket heir Russell Lund Jr. knew hours before police that the bullet-riddled bodies of Lund's estranged wife Barbara and Iowa lawyer Kevin Kelly were in Lund's secluded house in the affluent Minneapolis suburb of Minnetonka.

The slayings also may have occurred long before Lund's **Kelly** *Slain Iowan*

lawyers knew about them. Lund family members have told friends they believe Russell Lund was in the house with the bodies after the shootings on the afternoon of Aug. 5 while writing and dictating letters, the Minneapolis Star-Tribune reported Friday.

It was not until the next day that the lawyers arranged to meet the police chief of the suburb at a hotel, which touched off the investigation of the killings. Police also were handed the suspected murder weapon at the meeting, court documents released Friday show.

## A Mystery

Although a stainless-steel revolver that appeared to be blood-stained was handed over to police, the whereabouts of Lund, 59, remained a mystery. At the same time police were being told of the killings, the lawyers indicated that members of Russell Lund's family also were being notified, the documents state.

Minnetonka Police Chief Richard Setter met with the lawyers of Russell Lund at the Radisson Hotel at Ridgedale at 6:45 p.m. Aug. 6, more than two hours after receiving a call

from a man identifying himself as attorney David Rosten.

Rosten told Setter he had some information of "an extreme, urgent nature" that he would not discuss over the phone. What Setter didn't know at that time was that Rosten knew about the deaths of Barbara Lund and Kelly, a lawyer and lobbyist from Johnston, Ia.

When he arrived, Setter found Rosten, prominent defense attorney Joseph S. Frieberg and private detective Michael Grostyan at the hotel.

Setter was told the trio had information on a double homicide that had occurred at the Russell Lund residence. Court documents said that Setter was told by the attorneys "they could not state where Russell Lund was at this time but that he was not one of the victims."

When Setter asked who the victims were, the lawyers identified the victims as "Mrs. Russell Lund and the second party was an individual by the name of Kevin, with last name unknown."

Setter called other investigators to the home, and after they arrived, Grostyan went to his car, took the gun from the trunk and gave it to police. The revolver "had a splattering of a red substance along the barrel and cylinder," the court papers say.

## Attorneys' Role

At the meeting, Rosten, Frieberg and Grostyan would not say whether they represented any suspect in the case. The next day Frieberg confirmed that he was representing Russell Lund, police said.

Acting upon the information supplied to them by Lund's lawyers, police obtained search warrants for Lund's residence and found the bodies of Kelly and Barbara Lund.

Last Saturday, Lund, who reportedly was admitted to a Minneapolis hospital psychiatric unit under an assumed name, went to the Minnetonka police station for about 45 minutes. At that time he refused upon the advice of Rosten to answer questions. Lund reportedly remained under psychiatric care Friday. He had not been charged in the slayings.
