Arnold R. Lindeen

Arnold R. Lindeen, age 79, Swedesburg, died January 1, 1990 at his home in Swedesburg. The son of Rudolph and Anna (Sandburg) Lindeen, he was born May 9, 1910 at Swedesburg. On February 15, 1936 he married R. Marjorie Olson at Swedesburg; she died April 17, 1986.

Arnold was a graduate of the Olds High School and was a member of the Swedesburg Evangelical Lutheran Church and a member of the Swedish Heritage Society.

He was a retired farmer, farming in the Swedesburg community. He clerked at the Swedesburg Store from 1957-60; was Sales and Use Tax Auditor from 1962-66; was manager of the Henry County Credit Union from 1967-68; was Henry County Treasurer from 1969-74; he served as Iowa State Representative from 1975-78; he also had been president of the SVEA Mutual Insurance Association for many years.

Survivors include one daughter, Jane Wickham, RR 5, Mt. Pleasant; one son, Jerry Lindeen, Swedesburg; seven grandchildren; one brother, Virgil Lindeen, rural Winfield; three sisters, Ruth Johnson, Woodhull, Illinois; Ethel Benson and Virginia Lindeen, both of Swedesburg.

He was preceded in death by his parents, wife and one infant son.

The family will meet with friends Thursday, January 4, 1990 from 7 to 8 p.m. at the Honts Funeral Home, Winfield. Services will be Friday, January 5, 1990 at 1:30 p.m. from the Swedesburg Evangelical Lutheran Church, with Rev. Matthew Martens officiating. Music will be by Mary Benson, organist, and Bill Tolander, soloist. Interment will be in the Swedesburg Church Cemetery. A memorial has been established for the Swedesburg Evangelical Lutheran Church.

Honts Funeral Home, Winfield, was in charge of the arrangements.

Surviving are her husband; one son, Larry R. Lewis, Danville; two grandsons; and one great granddaughter.

She was preceded in death by a sister, Louise, and three brothers, William, Henry and Herman.
