Honor girls '72 state tournament basketball team here Saturday

The 1971-72 Ogden High School state tournament basketball team was honored between the boys and girls basketball games Saturday, Dec. 19, 2009 versus Woodward-Granger. To commemorate the event Phil Stone came back to do the announcing.

During the ceremony, OHS graduate Nancy Casey recounted the historical moment.

She said that five years ago we had the pleasure of honoring Ogden's first men's basketball team that made it to the state tournament. Tonight, the members of the 1952 team are here with their wives to help us honor another very important group of young women. Would you please join me in welcoming the 1952 men's team as I ask them to stand and be recognized: Bob Morgan, Harley Saunders, Lowell Morgan, Kenny

"A dream came true on that night in 1972 when you upset Ballard and sent the Ogden team to the state tournament. That was truly a come-from-behind classic. We were down nine points with a little over two minutes left to play. They thought they had won the game, but you all proved them wrong. Ballard did not know they were playing a 'come from behind' kind of team with a deep, gutsy bench.

"You were believers. You were dedicated, hard working athletes. You were a coachable team.

Tonight you are being honored for those characteristics that led you to that fantastic accomplishment. I truly do miss not being there with you tonight to help celebrate you well-deserved recognition. I wish you all well. Congratulations."

Kathy made 22/25 in the Sectional competition winning the opportunity to advance to the District level. Once again she sank 22 of 25 and advanced to the Regional competition. There, Kathy made 25/25 to win the competition, but they allowed her to continue shooting until she missed. Kathy made 81 free throws in a row to break the existing State of Iowa free throw record of 69. Sports Illustrated magazine featured an article about Kathy and her achievement.

The year was 1972. Six on six was the game. Three forwards, three guards and the three point shot did not exist! Under the direction of coaches John Kean and Jim Houchins, 15 young ladies pulled off the season of a lifetime. They went up against 26 opponents in their campaign to make it to Veterans Memorial Auditorium with a 22-4 record. The lady Bulldogs out-scored their opponents 15 times by double digits and two of their four losses were only one-point ball games!

District play consisted of three games. Ogden easily defeated Coon Rapids in the first, 50-42. The second game was a bit of a "nail biter" as the Bulldogs defeated Perry 42-41. But it was the District Championship game between Ogden and Ballard that most of us will never forget. What happened in the last 84 seconds of play has to be one of the most unbelievable finishes in Bulldog basketball history.

With one minute and 24 seconds on the clock, Diane Monthei put one in to bring Ballard's lead down to seven points. A critical steal in the guard court by Deb Townsend reignited the Bulldogs as Jeri Jean Doran drove in a layup, cutting the score, 70-65, with one minute left. Bulldog guard court pressure again caused two additional Ballard turnovers, landing the ball into the forward Jeri Jean Doran's hands, who drove in twice for four points, to bring the score within one point. It was 70-69 with 29 seconds to go.

A foul on Ogden put Ballard at the free throw line. The Bomberettes had been hot at the line all night long but they missed this one and it was Ogden who pulled in the rebound.

With the ball now in the Bulldog forward court again, with seven seconds to go, it was Diane Monthei who layed in the winning basket with four seconds remaining. Ballard took a shot in the final second of the game but missed.

The Bulldogs had indeed won the honor of advancing to the State Tournament and are presently the only Ogden girls team to do so.

Enter guilty pleas in dog-fighting ring

Zachary R. Connelly, 32 of Ogden, Ryan J. Tasler, 42, of Woodward, and Julio Reyes, 29, of Tecumseh, NE pled guilty last week for their parts in one of the largest coordinated dog fighting rings in United States history.

Connelly admitted to transporting a pit bull from Iowa to Gilman City, Mo, to participate in dog fights at the residence of co-defendant Cris E. Bottcher, 48. Tasler admitted to assisting Connelly. Reyes admitted to transporting the dogs from Nebraska to Missouri on two different dates. Three other co-defendants, including Kevin P. Tasler, 51, of Jefferson, also pled guilty in the case.

"Under federal statutes, each of the defendants is subject to a sentence of up to five years in federal prison without parole, plus a fine up to \$250,000 and an order of restitution," said Don Ledford spokesman for the U.S. Attorney's Office for the Western District of Missouri.
