C. M. BROWN IS BURIED

WELL KNOWN ATTORNEY OF
THIS PLACE SUCCUMBS.

Large Concourse of Friends Gathered to Pay Last Tribute of Respect to the Memory of C. M. Brown.

The funeral of C. M. Brown was held at the Presbyterian church Monday afternoon, conducted by Rev. Vincent, his pastor and the G. A. R. and I. O. O. F. and the Keokuk county bar in a body. The sudden death of Mr. Brown, which we chronicled last week, threw a pall over the town, on account of its suddenness and the high regard in which he was held by the people of this place. No one knows just the manner of his death, for Mr. Bensmiller found him some time after life had been extinct, on the floor of his office where he had evidently fallen, while in the act of talking at the telephone or going to make a call over it.

C. M. Brown was born in Knox county, Ohio, Nov. 9th, 1845, and was at the time of his death, aged 67 years, 5 months and 29 days. During the war, he enlisted in the 142nd Ohio Volunteers, and served his country until mustered out at the close of the war. He taught school after the close of the war, then came on to this state, settling in Muscatine in 1868. He attended the State University and graduated in the law class of 1871, coming on then to Sigourney, where he has since been located except for a few years, which he spent in What Cheer. He was a



ten. His home life was ideal and in that station will be missed the most, for he leaves in his character and good name, a heritage that is priceless and one that will live long after him.

Accepting of the responsibilities thus placed upon him by his fellow followers of Christ, he was ordained and installed ruling Elder April 7th, 1907, and was serving in that capacity at the time of his translation, also was a teacher in the Sabbath school. Charles Henry Brower, the sixth child of Charles C. and Naomi Brown Brower graduated from Kinross High School. He enrolled in the Iowa Success School in Ottumwa, Iowa taking classes in business and accounting. He accepted a position at Dain Manufacturing Co. (now known as John Deere) in the purchasing department.

On October 5, 1940 Charles and Grace Emily Robison were married. She is the daughter of Cyrus M. and Bertha Smith Robison. She attended Plank # 2 school through 8th grade and graduated from South English High School. She attended William Penn summer school to obtain her rural school teaching certificate, and taught at Talleyrand and Plank # 2 schools.

Charles and Grace are the parents of 6 children: Carolyn Jean (July 11, 1941) married to John Semonco and living in Fulton, Maryland; Charles Douglas (December 24, 1942) married to Gloria Ballard, living in Rochester, Minnesota; Gregory Lee (August 26, 1946) married to Kathy Streigle, living in Richland; Kevin Mark (December 23, 1954) married to Dorie Miller, living in Cedar Rapids; Keith Alan (March 19, 1956) married to Shari Puhly, living in Burlington, Iowa and Lori Dianne (September 4, 1962) married to Oren Phillips, living in Pella, Iowa.

There are 14 living grandchildren and 5 great-grand children.

In June of 1942, Charles enlisted in the Army Air Force, and received training as an airplane mechanic. He spent thirty-nine months in the service, twenty-four of them in England in the 8th Air Force during the Battle of Britain. He served as assistant crew chief on a B-17-F four engine Bomber as airplane and engine mechanic. His unit participated in six major battles and campaigns, air offense Europe, Central Europe, Normandy, Northern France, Rhineland and Ardennes. He was awarded six bronze stars for the above campaigns; received a good conduct medal and a Distinguished Unit Badge, lapel button and European- African and Middle Eastern Theatre campaign insignia and four overseas bars.

Upon discharge from the service, he returned to John Deere in Ottumwa, and was immediately promoted to the position of chief hardware buyer in the Purchasing department. The company was expanding rapidly, and due to shortages by the war it was necessary to spend long hours trying to find the hardware items and rubber tires, etc. It began to affect his health, so in 1951, they moved back to South English area, purchasing land from Grace's elderly father. They built their own house next door to her parents and started farming and helping her parents on their farm.

In the following years, Charles worked as a carpenter, Chief Dispatcher at Kingsberry Homes factory in Sigourney and served as Keokuk County Clerk of District Court for four years. He worked at Amana Refrigeration, retiring from there in 1981.

A love of sewing turned into a home-based business in 1978 when people became acquainted with the Teddy Bears and other toys made by Grace. A shop was built, adjoining the house to display the toys, quilts and many other hand crafted items. In addition to selling from their shop, several Craft Shows are attended each year. C. (Cassius) M. Brown was born in Knox County, Ohio in 1845, the son of Garretson and Anna (Holland) Brown. In

1871 he graduated from the University of Iowa Law Department and set up practice in Sigourney, Iowa. In 1872 his parents moved from Knox County, Ohio to Keokuk County, Iowa. They continued farming here in Iowa. Garretson Brown, of Welsh descent was born in Maryland in 1802. His wife, of German descent was born in West Virginia. She died in 1874 at the age of seventy and Garretson died in 1889. Except for about five years spent in What Cheer, C. M. Brown practiced law in Sigourney all his life. He was a state senator for four years. In 1874 he married Miss Flora Sampson, daughter of Judge Ezekiel Silas Sampson of Sigourney. They had four children: Eunice Anna, who married Ernest Elisha Brackin and farmed in the Coal Creek/Indianapolis area; Roy C., an attorney who practiced law with his father having charge of the What Cheer office; Millie, who was a nurse and served in France in WWI and later married Jerry Sebest; and Helen, who married William Fraser Smith, a dentist in Regina, Sask, Canada.

Ernest and Anna (Brown) Brackin had five children, the eldest being Eunice Ellen, named after her great grandmother, Eunice Ellen Sampson. Ellen married A.C. McIntosh and farmed in the area, until retiring into Oskaloosa in 1970. They had five Children, Marie, Helen, A.C., Junior, Delmar and Elizabeth who died at birth. Marie married Chet Wymore of Rose Hill, Iowa. They farmed in Wapello County and had one daughter, Marjorie Spencer of Anamosa, IA. Helen married Joseph Hoskins, farmed in the Fremont area and now lives in Oskaloosa. They have a daughter, Marilyn who married Gary Thompson and lives in Flushing, MI.; and son, Joe Jr. who farms in the Fremont area with his son, Otis. Junior married Ruth Fry and they had four sons, Rodger, Leslie, Cary and Keith. Ruth died in 1961. Junior later married Roberta Pell and they had a son, Chris. Delmar married Betty Beach and they had three children, Larry, Linda and Connie. Junior and Delmar both moved their families to Denver, Colorado and worked for United Airlines. Ernest and Anna's other children were Roy, Dorothy, Paul and Robert. Roy, a physician in Chicago, retired to the Brackin home in Oskaloosa. He married Genevieve Ryan and has two daughters, Anna and Marcia. Dorothy married Ivan Dale Applegate and had two sons, Gerald and Leon. Paul died of ear infection at age 18. Robert "Bob" married Blanche McCormick and farmed the family farm. They had five children, Mary who died as an infant; Robert junior, who lives in Colorado; Laura Ann Shisler who lives in California; Benjamin who lives in Missouri; and Paul who married Susan Lee Hudson and lives near Pella, IA. Calvin Leroy Brown was born in Ottumwa, Wapello County, Iowa on April 25, 1919 to Ona and Oris C. Brown but from the age of 18 months was reared by his Mother and Stepfather, Richard L. Chrisman. Winifred Marie Sheridan was born in East Lancaster Township, Lancaster Community,

Keokuk County, to Raymond E. and Bessie Clingan Sheridan on July 14, 1918.

Both graduated from Sigourney High School in 1936. Because of the depression, Leroy could not find employment in the surrounding area, so continued to work for his Step-Father, who was an independent poultry buyer for a wage of \$1.00 a day and room and board. Winifred went to Des Moines and graduated from Capital City Commercial College with a bookkeeping degree and began work as a clerk in Keokuk County Auditor's office, Sigourney in 1938. She worked 2 years.

September 14, 1940 the Browns married in Sigourney at the Sigourney Christian Church parsonage by Rev. Leo Potter. Winifred became a homemaker and Leroy began his own poultry buying business, securing the poultry from individual farms on a daily basis and hauling it live into Swift & Co., Ottumwa. He accumulated 350 individual accounts before enlisting in December 1943 in the Army Air Force. His active duty began February 1944 and he served 22 months. Leroy was a nose gunner on a B-24 Liberator with the 15th Air Force, 98th Bomb Group, 345th Squadron in Italy, flying 40 missions over Europe. He returned to his poultry business, but phased out shortly due to the farmers discontinuing their individual flocks.

In 1948, Winifred and Leroy purchased a farm on the outskirts of the former town of Lancaster, East Lancaster Township. The abstract contains many of the Out Lots and Streets of the old town of Lancaster.

They farmed and raised broilers and laying hens and established the Brown Feed and Supply Store on their farm. It was stocked with Swift & Nixon feed in 50# bags, equipment for livestock and medications. Later we added Behlen Grain Bins and Grain handling equipment, sales and service. The steel was hauled from Columbus, Nebraska by Leroy in his own semi. All feed was also handled by their trucks.

C. M. Brown is a native of Knox county, Ohio. He was born November 9, 1845, and is the son of Garretson and Ann (Holland)

Brown. The father was of Welsh descent. His early ancestors settled in Maryland and there, in Montgomery county, Garretson was born in 1802. His wife was of German descent, one of a family of twelve children who all grew to maturity. She was born in Monongalia county, West Virginia, and for a short time after her marriage to Mr. Brown continued to live in her native state. Later they moved to Knox county, Ohio, where Mr. Brown engaged in farming for many years. In 1872 they settled in Keokuk county, this state, still interested in farming. The wife died in 1874 at the age of seventy, and the husband remained on his farm until the time of his death in 1889. Three of their nine children died in infancy, four are now living; two sons and one daughter in Keokuk county and one son in Muscatine county.

C. M. Brown was reared on the farm in Ohio and his education was begun in the district schools of the county. Later he entered the high school at Mt. Vernon, Ohio, and subsequently spent a year at Kenyon College in Gambier, Ohio. He taught school for two terms in his native state and in 1868 came west and taught for two years in the schools of Muscatine county, Iowa. Before leaving Ohio he had already begun the study of law and in 1871 he graduated from the law department of the state university at Iowa City. He at once located in Siggourney, where he has continued ever since with the exception of about five years spent at Whatcheer, Iowa. He is actively concerned with the political affairs of his state. In 1881 his party, the Republican, nominated him for state senator. He was elected and held the office for four years. In 1874 he married Miss Flora Sampson, daughter of Judge E. S. Sampson. He has served for one year on the staff of the national commander of the Grand Army of the Republic, an index of Mr. Brown's popularity and executive ability.

Coffman, was a native of Virginia and pursued his education in Shurtleff College, at Chicago, and Morgan Park Seminary. About 1865 he took up his abode in Washington county, Iowa, and for some time was also located in Burlington. He is now retired from the ministry and makes his home at Keota, but his interest in church work is deep and abiding and his influence is yet given to the advancement of the cause of Christianity, of which he was so long a faithful representative in ministry.
