

O. H. FRINK EX-MAYOR IS DEAD

Passed Away at His Home Tuesday Morning.

BEEN ILL FOR TWO YEARS WITH PARALYSIS

Deceased Also Served Two Terms in the State Legislature from this County, as Well as County Treasurer.

O. H. Frink, one of Page county's best known citizens, died at his home on Clarinda avenue, Tuesday morning, July 25, at 9:15 o'clock after a lingering illness of about two years, during a greater part of which time he has been practically helpless. The funeral is to be held this afternoon at 3 o'clock at the Baptist church, conducted by the pastor, Rev. E. F. Jordan. The G. A. R., of which order the deceased was an honored member, will have charge of the services at Rose Hill cemetery, where interment is to be made.

About two years ago Mr. Frink was seized with a nervous disorder which developed into a slow paralysis. He has been confined to his bed and to an invalid's chair practically all of the time since. He received the very best of medical care and nursing, and while he seemed to suffer but little physical pain, he gradually grew weaker until death came to his relief.

O. H. Frink was born in Elkhart, Ind., May 26, 1848. His father died the same year, and his mother lived but about five years later. Left an orphan at this early age he was reared by a guardian until he took up his residence with a married sister at Kewanee, Ill. It was from this point that he enlisted when 16 years of age in Co. A, 124th Ill. Infantry, later transferring to the 33d and serving until discharged in November 1865.

On April 12, 1870, he was united in marriage to Miss Barbara E. Minnick, at Kewanee, and the year following they moved to Page county, where Mr. Frink bot a farm, and this county has since been his home. After living on this farm for a number of years he was elected county treasurer in 1890, which he retained for six years, living at Clarinda during that time. He was elected to the state legislature from this county and served during the 26th and 27th general assemblies. He then retired to his farm where he lived until moving to Shenandoah in 1903, and then went into the heating and plumbing business, having first as a partner, Mr. C. A. Hamilton. He later purchased Mr. Hamilton's interest and carried on the work alone until selling out in 1908, when he retired from active business life.

Another 250,000 Gallon Pump Being Installed This Week.

CITY USED 450,000 GALLONS OF WATER ON TUESDAY

Demand for Water Greater Than Can Be Supplied With Present Pump, but Situation Will Soon Be Remedied.

For the first time in a long while it was necessary to go without water for a short period Tuesday evening. The heavy demands on the water have been such the past few days that it was impossible to pump it as fast as it was used.

Tuesday, 450,000 gallons of water was pumped and it was all used before night. The new water tank, which holds 400,000 gallons, has a slight leak in it, and while it is full of water to be used as fire protection, it is not intended to connect it to the mains until it has been accepted by the city, and it will not be accepted until the contractor has calked it so as to prevent any further leaks.

The city is busy fixing the old pump, which has a capacity of 250,000 gallons per day, to add to the present equipment for pumping, and as soon as the work on that is done, which will be this week, the pumping capacity will be at least 700,000 gallons per day, and it is that this will keep things pretty well supplied even tho there are some heavy users of water on the system.

Tuesday an average of 75 gallons of water for every man, woman and child in the corporate limits of the city was used. This is some water and everybody should have at least one bath.

The power at the Electric light plant was shut down for 20 minutes today to connect up with the new additional pump. Pumping will commence on this second pump tomorrow morning.
