**FUNDING SUMMARY**

---

**FY 2016:** Appropriates a total of \$174.6 million from the General Fund to the Judicial Branch. This is no change in funding compared to estimated FY 2015.

Page 1, Line 2

**FY 2017:** General Fund appropriations to the Judicial Branch for FY 2017 are made in Division II of SF 496 and equal 50.0% of the FY 2016 appropriations.
