

**123.26 Restrictions on sales — seals — labeling.**

Alcoholic liquor shall not be sold by a class “E” retail alcohol licensee except in a sealed container with identifying markers as prescribed by the director and affixed in the manner prescribed by the director, and no such container shall be opened upon the premises of a state warehouse. The department shall cooperate with the department of natural resources so that only one identifying marker or mark is needed to satisfy the requirements of [this section](#) and [section 455C.5, subsection 1](#). Possession of alcoholic liquors which do not carry the prescribed identifying markers is a violation of [this chapter](#) except as provided in [section 123.22](#).
