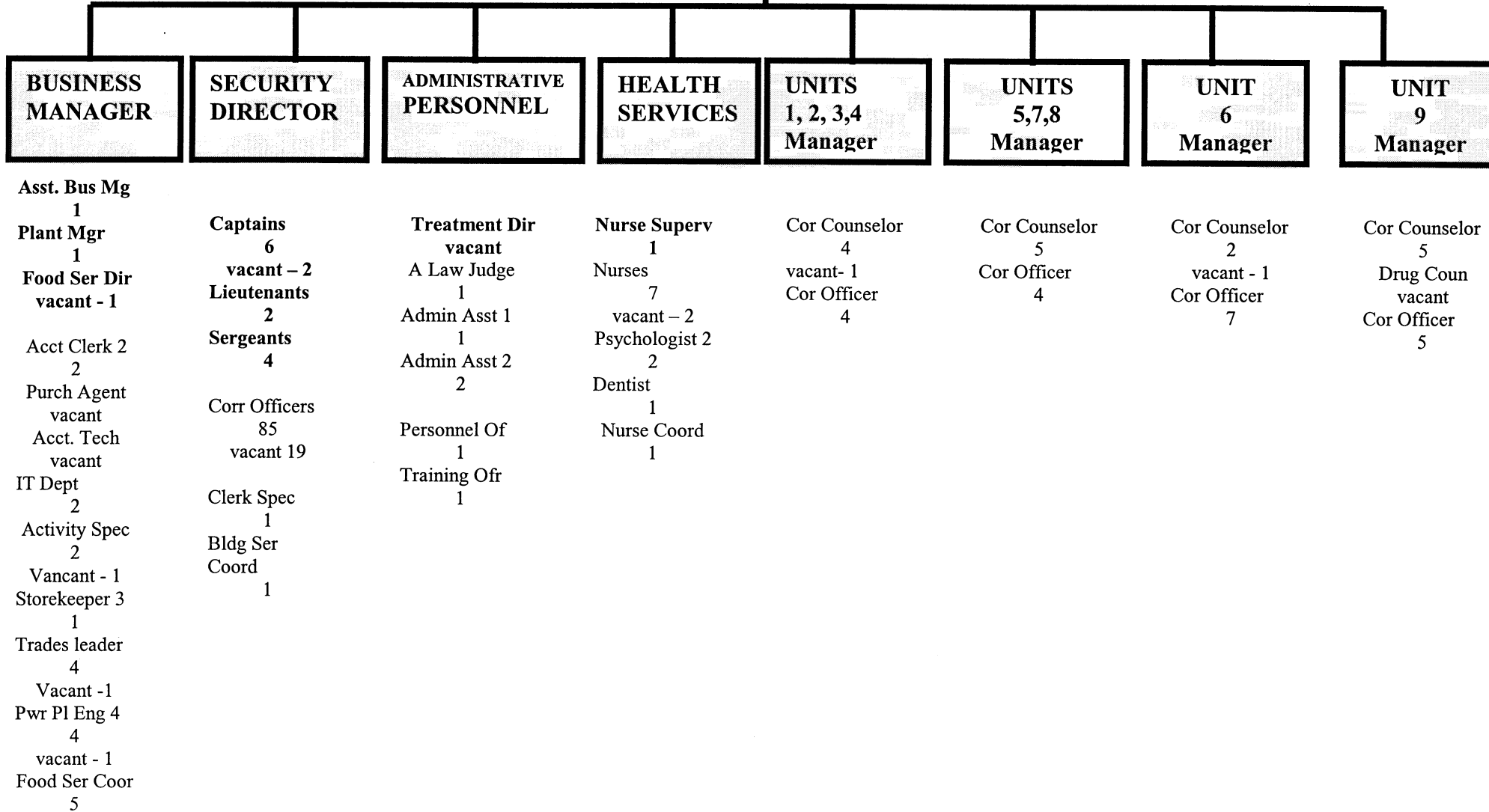
Organizational Chart: July, 2002

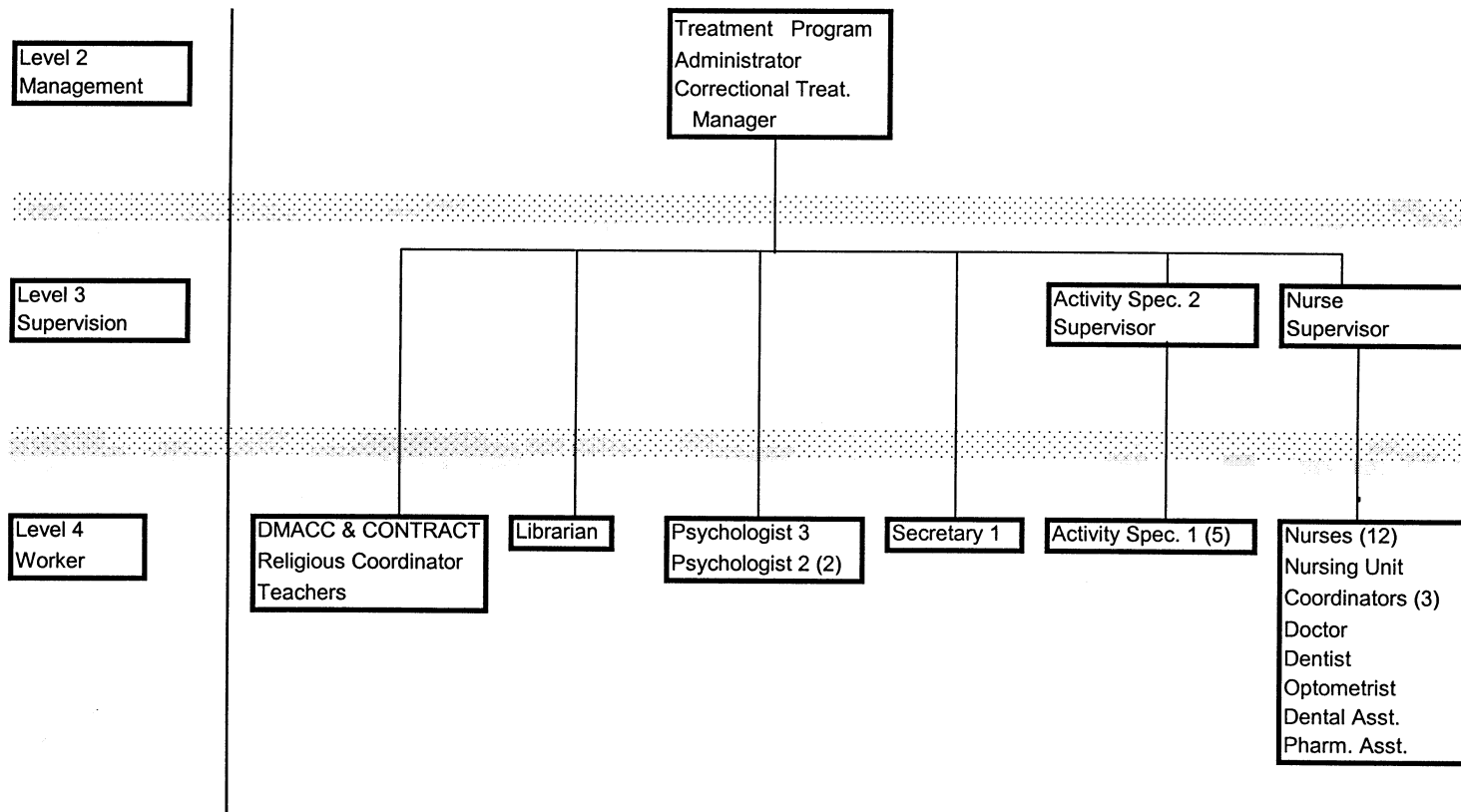
NEWTON CORRECTIONAL FACILITY NEWTON, IOWA TABLE OF ORGANIZATION



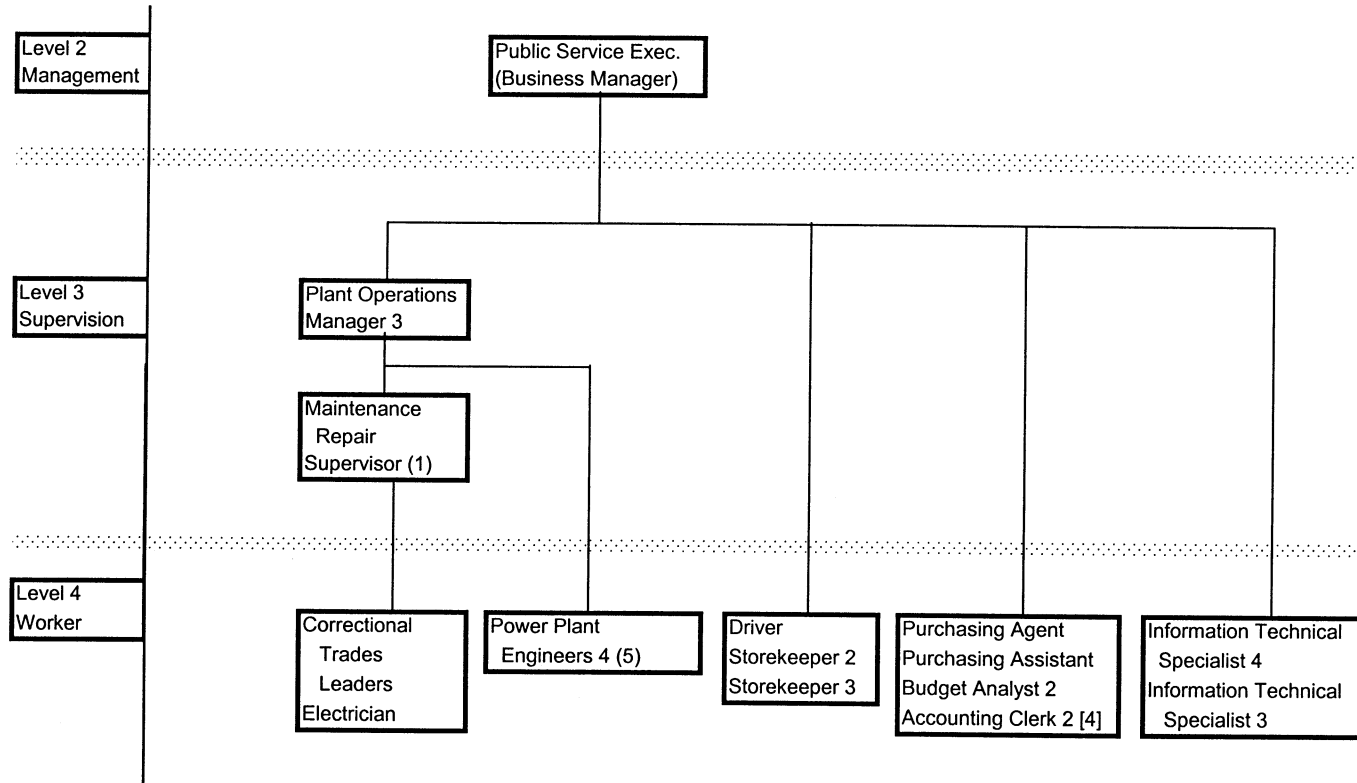

Work Release Center has 81 beds for work release, OWI sentenced offenders, and federal offenders. Residential Corrections Facility has 64 beds for probationers and work release.

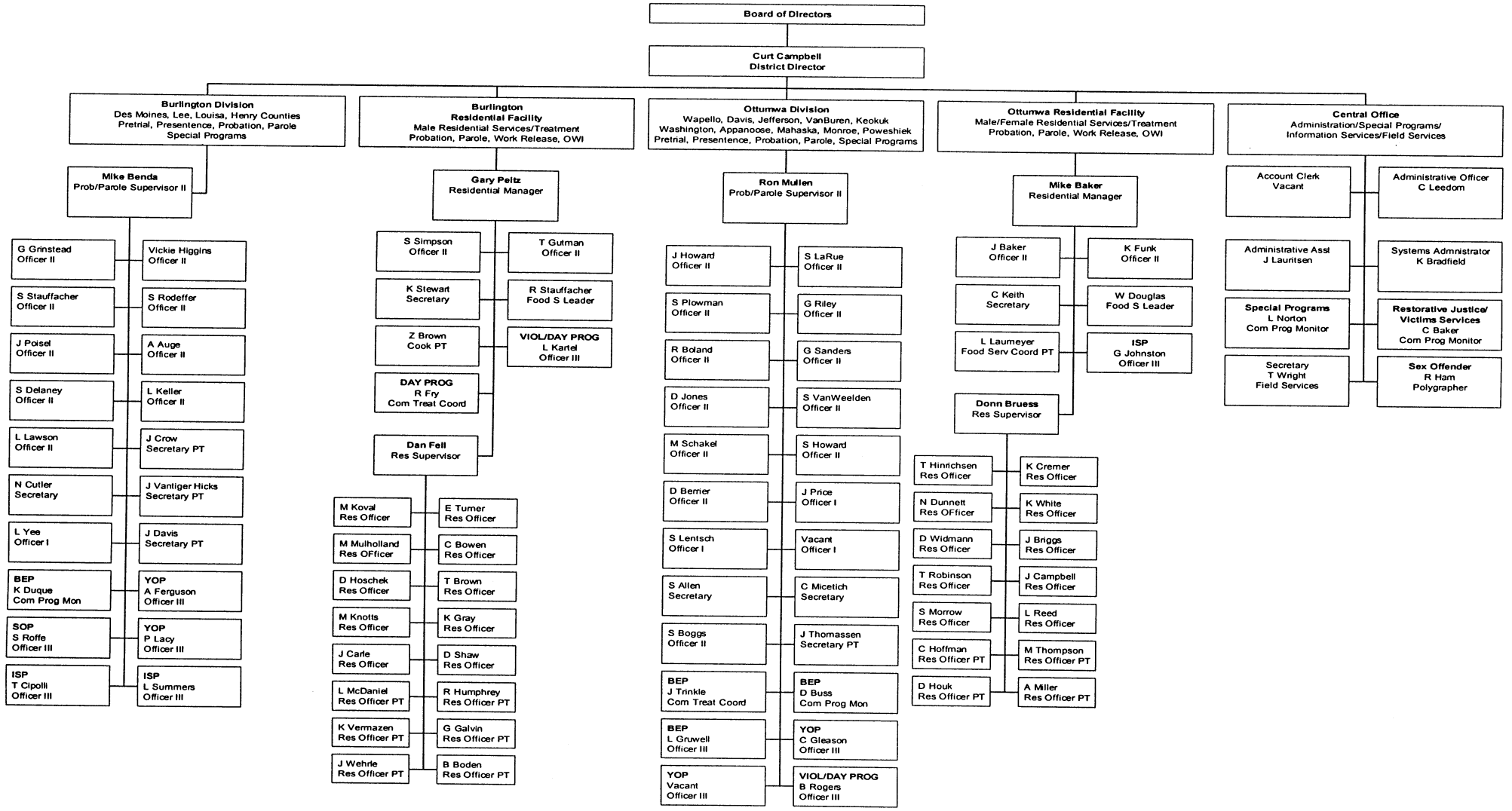

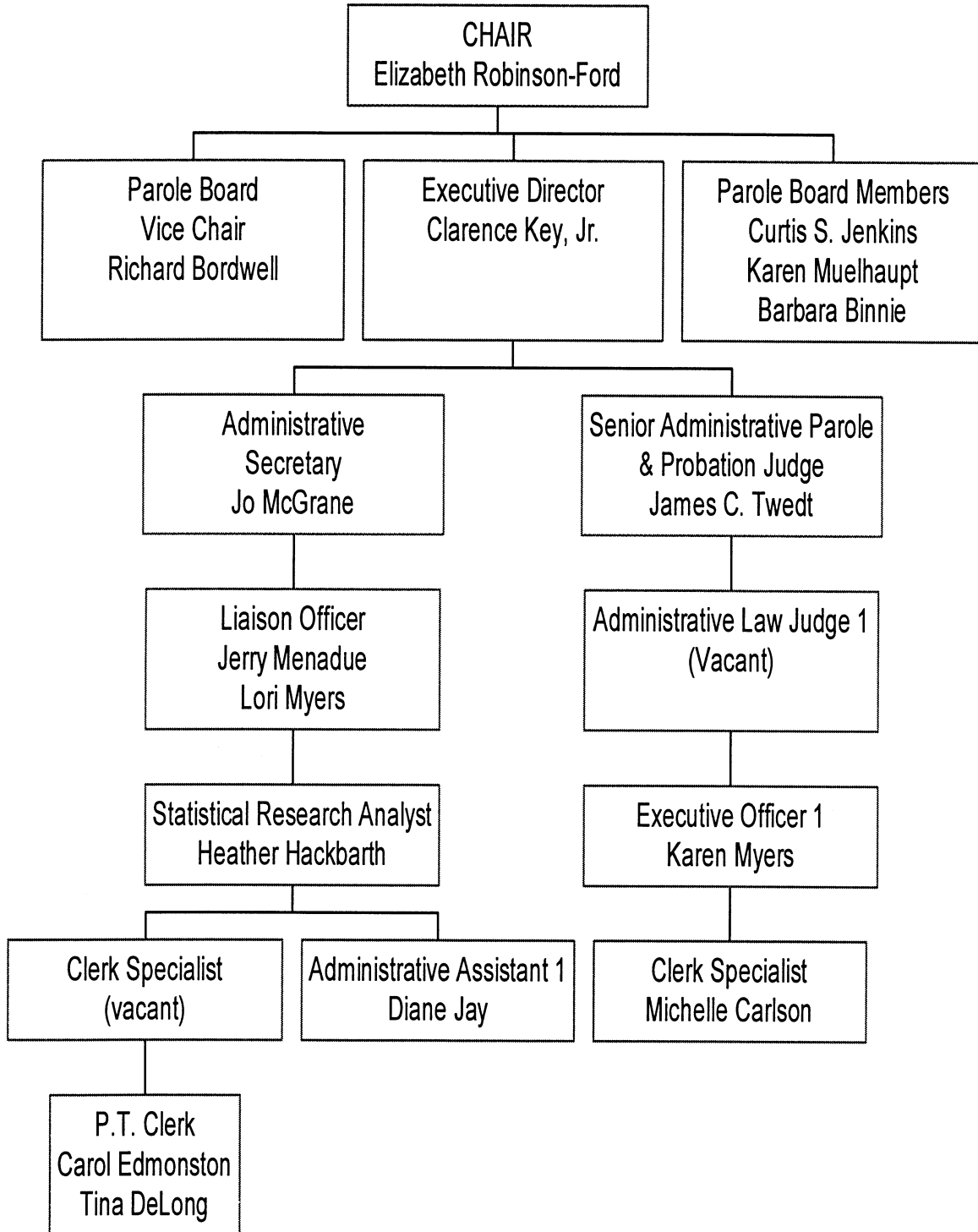


IOWA LAW ENFORCEMENT ACADEMY TABLE OF ORGANIZATION

Organizational Chart



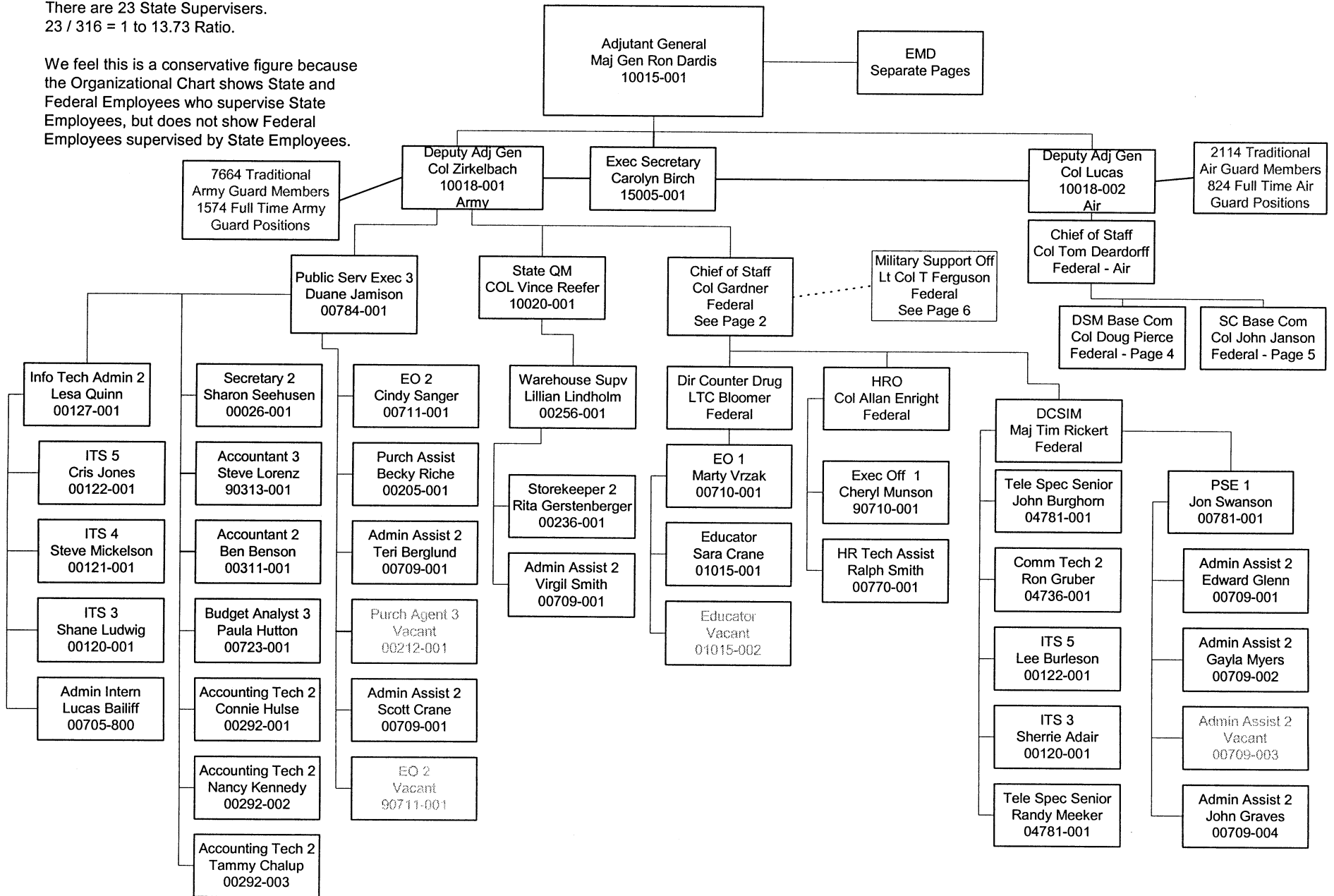
