Cherokee Mental Health Institute:

Northwest Iowa's 60 bed facility houses 48 adult acute psychiatric inpatient beds, 6 children's acute psychiatric inpatient beds and 6 adolescent acute psychiatric inpatient beds. Cherokee operates a school on-campus to provide education for the child and adolescent patients as well as an on-campus psychiatric specialty physician assistant training program. Cherokee child and adolescent programs accept patients from the western half of the state; the adult psychiatric program accepts admissions from the 41 county catchment area. The mental health institute is funded through an up-front state appropriation. Counties reimburse the state 80% of a capped per diem for the cost of care for adults with a county of legal settlement. The state is responsible for the cost of care of persons under 18 years of age and for adults with no county of legal settlement.

Clarinda Mental Health Institute:

Southwest Iowa's 55 bed facility houses 20 adult acute psychiatric inpatient beds and 35 adult Gero-psychiatric inpatient beds. The MHI is co-campused with a Department of Corrections facility. The adult program accepts admissions from a 15 county catchment area; the Gero-psychiatric program accepts admissions from the entire state. The mental health institute is funded through an up-front state appropriation. Counties reimburse the state 80% of a capped per diem for the cost of care for adults with a county of legal settlement. The state is responsible for the cost of care for adults with no county of legal settlement.

Independence Mental Health Institute:

Northeast Iowa's 95 bed facility houses 40 adult acute psychiatric inpatient beds, 15 children's acute psychiatric inpatient beds, 10 acute psychiatric inpatient beds for adolescents and a 30 bed PMIC facility for children and adolescents. Independence child and adolescent programs accept patients from the eastern half of the state; the adult psychiatric program accepts admissions from the 28 county catchment area. The PMIC only accepts admissions from the Independence or Cherokee children and adolescent programs and the Iowa Juvenile Home. The mental health institute adult and children and adolescent programs are funded through an up-front state appropriation. Counties reimburse the state 80% of a capped per diem for the cost of care for adults with a county of legal settlement. The state is responsible for the cost of care of persons under 18 years of age and for adults with no county of legal settlement. The PMIC program operates under a net budgeting concept under which funding is a mix of state dollars and revenue received attributable to the program. Counties do not have any financial responsibility for the cost of care of children at the PMIC.

Mount Pleasant Mental Health Institute:

Serving the Southeast quadrant of the State, the Mount Pleasant facility houses 14 adult acute psychiatric inpatient beds and 15 dual diagnosis inpatient beds serving adults with both a mental illness & substance abuse diagnosis. The MHI is currently operating an interim 30-bed adult residential substance abuse program until the 2003 legislature determines if the program should be funded in FY 03. The substance abuse and dual diagnosis units accept patients from all Iowa counties; the adult psychiatric program accepts admissions from the 15 county catchment area. The MHI is co-campused with a Department of Corrections facility. The mental health institute adult psychiatric program is funded through an up-front state appropriation. Counties reimburse the state 80% of a capped

per diem for the cost of care for adults with a county of legal settlement. The state is responsible for the cost of care for adults with no county of legal settlement. The dual diagnosis program operates under a net budgeting concept under which funding is a mix of state dollars and revenue received attributable to the program. Counties are responsible for 50% of the actual cost of care for persons with a county of legal settlement. The state is responsible for the cost of care for adults with no county of legal settlement. The substance abuse program has previously been funded through an up-front state appropriation. Counties reimburse the state 25% of a capped per diem for the cost of care for adults with a county of legal settlement. The state is responsible for the cost of care for adults with no county of legal settlement. Well over 80% of the persons served in the substance abuse program come from the correctional system.

Glenwood State Resource Center:

The Resource Center at Glenwood is a 405 bed ICF/MR that provides diagnostic evaluation, treatment, training care, habilitation and support to persons with mental retardation and other disabilities. Glenwood serves persons from a 52 county catchment area. Glenwood also serves 15 persons under the home and community based waiver program at 5 locations. Other programs provided are respite and time limited assessments as well as other family support and community outreach services. The GRC operates under a net budgeting concept in which funding is a mix of state dollars and revenue received attributable to the program. Counties reimburse the state 80% of a capped per diem for the cost of care for adults with a county of legal settlement who are not Medicaid eligible and 100% of a capped per diem for adults with a county of legal settlement and for the cost of care for persons under 18 years of age.

Woodward State Resource Center:

The Resource Center at Woodward is a 286 bed ICF/MR that provides diagnostic evaluation, treatment, training care, habilitation and support to persons with mental retardation and other disabilities. Woodward serves persons from a 47 county catchment area. Woodward also serves 12 persons under the home and community based waiver program at 4 locations. Other programs provided are respite and time limited assessments as well as other family support and community outreach services. The WRC operates under a net budgeting concept in which funding is a mix of state dollars and revenue received attributable to the program. Counties reimburse the state 80% of a capped per diem for the cost of care for adults with a county of legal settlement who are not Medicaid eligible and 100% of a capped per diem for adults with a county of legal settlement who are Medicaid eligible. The state is responsible for the cost of care for adults with no county of legal settlement and for the cost of care for persons under 18 years of age.
