Auditor of State Mary Mosiman today released a report on the University of Northern Iowa, Cedar Falls, Iowa for the year ended June 30, 2016. The University of Northern Iowa previously released its annual financial report for the year ended June 30, 2016.

The University of Northern Iowa is governed by the Board of Regents. For the fiscal year ended June 30, 2016, the full-time equivalent student enrollment was 9,708 with an average cost per student of \$14,836 compared to 9,765 students and an average cost per student of \$14,960 for the fiscal year ended June 30, 2015.
