1 47 following is guilty of a fraudulent practice in the
1 48 fourth degree pursuant to section 714.12:
1 49 1. A false original or false copy of the
1 50 notification document mailed to a parent of a pregnant
2 1 minor or a false copy of the order waiving
2 2 notification relative to the termination of parental
2 3 rights of a pregnant minor.
2 4 2. A false original or a false copy of the
2 5 notification document mailed to a parent of a pregnant
2 6 minor or a false copy of the order waiving
2 7 notification relative to the performance of an

2 8 abortion on a pregnant minor.""

2 18 #____. Title page, by striking lines 1 through 3,
2 19 and inserting the following:
2 20 "An Act relating to the required notification of a
2 21 parent prior to the performance of an abortion on a
2 22 minor or prior to the termination of a pregnant
2 23 minor's parental rights for the purpose of placing a
2 24 child for adoption, providing for exceptions, and
2 25 providing penalties.""
