2 5 "2. In addition to any other penalty, at the time
2 6 of conviction for a public offense committed on or
2 7 after the effective date of this Act which requires a
2 8 person to register under this chapter, the person

2 8 shall be assessed a civil penalty of two hundred
2 9 dollars, to be payable in the same manner as a fine.
2 10 The clerk of the district court shall transmit money
2 11 collected under this subsection each month to the
2 12 treasurer of state, who shall deposit the money in the
2 13 sex offender registry fund established under section
2 14 692A.11."
