1 1 Amend [House File 2182](#) as follows:
1 2 #1. By striking everything after the enacting
1 3 clause and inserting the following:
1 4 "Section 1. NEW SECTION. 135.23 GROUP B
1 5 STREPTOCOCCUS TESTING.
1 6 1. A physician providing prenatal care shall
1 7 routinely furnish pregnant patients with concise
1 8 written information, to be developed by the
1 9 department, regarding group B streptococcus disease
1 10 incidence, risks, prevention strategies, diagnosis,
1 11 and treatment. If a patient requests to be tested for
1 12 the presence of group B streptococcus, the physician
1 13 may perform a screening culture between the thirty-
1 14 fifth and thirty-seventh weeks of pregnancy.
1 15 2. The physician shall inform a patient who has
1 16 been tested of the test result. If a patient has
1 17 tested positive for group B streptococcus, the
1 18 physician or a designated member of the physician's
1 19 staff shall report this status to the hospital or
1 20 birth facility to which the patient is to be admitted.
1 21 This information shall be entered upon the patient's
1 22 medical records by a physician or designated hospital
1 23 or birth facility staff member prior to or at the time
1 24 of delivery.
1 25 3. As used in this section, "physician" means a
1 26 physician licensed to practice medicine and surgery or
1 27 osteopathic medicine and surgery.
1 28 4. If the centers for disease control and
1 29 prevention of the United States department of health
1 30 and human services, with the concurrence of the
1 31 American academy of pediatrics and the American
1 32 college of obstetrics and gynecology, determines that
1 33 culture screenings of pregnant women to identify those
1 34 who may have a positive screening result as a strategy
1 35 to prevent the onset of group B streptococcus disease
1 36 in newborns is no longer the most appropriate
1 37 strategy, is no longer indicated, or is replaced by a
1 38 treatment modality which renders the screening
1 39 unnecessary, the director shall adopt rules pursuant
1 40 to section 17A.4, subsection 2, and section 17A.5,
1 41 subsection 2, paragraph "b", to reflect the
1 42 determination.
1 43 Sec. 2. The director of public health shall adopt
1 44 rules pursuant to section 17A.4, subsection 2, and
1 45 section 17A.5, subsection 2, paragraph "b", necessary
1 46 to administer this section, and the rules shall become
1 47 effective July 1, 1996."
