1 6 imposed for a violation of this subsection shall
1 7 include assessment of a fine of not less than two
1 8 hundred fifty dollars nor more than one thousand five
1 9 hundred dollars."
1 10 #2. Page 2, line 7, by inserting after the word
1 11 "jurisdiction." the following: "In addition to any
1 12 other penalties, the punishment imposed for a
1 13 violation of this subsection shall include assessment
1 14 of a fine of not less than two hundred fifty dollars."
1 15 #3. Page 2, line 15, by inserting after the word
1 16 "misdemeanor." the following: "In addition to any
1 17 other penalties, the punishment imposed for a
1 18 violation of this subsection shall include assessment
1 19 of a fine of not less than two hundred fifty dollars."
1 20 #4. Page 2, by striking lines 28 and 29 and
1 21 inserting the following: "penalties, the punishment
1 22 imposed for a violation of this subsection shall
1 23 include assessment of a fine of not less than two
1 24 hundred fifty dollars nor".
1 25 #5. Page 3, by striking lines 4 and 5, and
1 26 inserting the following: "addition to any other
1 27 penalties, the punishment imposed for a violation of
1 28 this subsection shall include assessment of a fine of
1 29 one thousand dollars."
1 30 #6. Page 3, line 35, by inserting after the word
1 31 "misdemeanor." the following: "In addition to any
1 32 other penalties, the punishment imposed for a
1 33 violation of this subsection shall include assessment
1 34 of a fine of not less than two hundred fifty dollars."
1 35 #7. Page 6, line 21, by inserting after the word
1 36 "misdemeanor." the following: "In addition to any
1 37 other penalties, the punishment imposed for a
1 38 violation of this subsection shall include assessment
1 39 of a fine of not less than two hundred fifty dollars."
1 40 #8. Page 6, line 35, by inserting after the word
1 41 "misdemeanor." the following: "In addition to any
1 42 other penalties, the punishment imposed for a
1 43 violation of this section shall include assessment of
1 44 a fine of not less than two hundred fifty dollars."
1 45 #9. Page 7, line 15, by inserting after the word
1 46 "misdemeanor." the following: "In addition to any
1 47 other penalties, the punishment imposed for a
1 48 violation of this section shall include assessment of
1 49 a fine of not less than two hundred fifty dollars."
