## Amendment Text

1 1 Amend [Senate File 470](#), as amended, passed, and  
1 2 reprinted by the Senate, as follows:  
1 3 #1. By striking everything after the enacting  
1 4 clause and inserting the following:  
1 5 "Section 1. Section [56.2](#), Code 1999, is amended by  
1 6 adding the following new subsections:  
1 7 NEW SUBSECTION. 5A. "Clearly identified" means  
1 8 that a communication contains an unambiguous reference  
1 9 to a particular candidate or ballot issue, including  
1 10 but not limited to one or more of the following:  
1 11 a. Use of the name of the candidate or ballot  
1 12 issue.  
1 13 b. Use of a photograph or drawing of the  
1 14 candidate, or the use of a particular symbol  
1 15 associated with a specific ballot issue.  
1 16 c. Use of a candidate's initials, nickname,  
1 17 office, or status as a candidate, or use of acronym,  
1 18 popular name, or characterization of a ballot issue.  
1 19 NEW SUBSECTION. 12A. "Express advocacy" or to  
1 20 "expressly advocate" means communication that can be  
1 21 characterized according to at least one of the  
1 22 following descriptions:  
1 23 a. The communication is political speech made in  
1 24 the form of a contribution.  
1 25 b. In advocating the election or defeat of one or  
1 26 more clearly identified candidates or the passage or  
1 27 defeat of one or more clearly identified ballot  
1 28 issues, the communication includes explicit words that  
1 29 unambiguously indicate that the communication is  
1 30 recommending or supporting a particular outcome in the  
1 31 election with regard to any clearly identified  
1 32 candidate or ballot issue.  
1 33 c. When taken as a whole and with limited  
1 34 reference to external events such as the proximity to  
1 35 the election, the communication could only be  
1 36 interpreted by a reasonable person as supporting or  
1 37 recommending the election, passage, or defeat of one  
1 38 or more clearly identified candidates or ballot issues  
1 39 because both of the following conditions are met:  
1 40 (1) The communication, as it relates to the  
1 41 election or defeat of the candidate or ballot issue,  
1 42 is unmistakable, unambiguous, and suggestive of only  
1 43 one meaning.  
1 44 (2) Reasonable minds could not differ as to  
1 45 whether the communication encourages action to  
1 46 nominate, elect, approve, or defeat one or more  
1 47 clearly identified candidates or a ballot issue or  
1 48 whether the communication encourages some other kind  
1 49 of action.

4 39 political committee on behalf of a candidate, if known  
4 40 and approved by the candidate, shall be deemed action  
4 41 by the candidate and reported by the candidate's  
4 42 committee. It shall be presumed that a candidate  
4 43 approves the action if the candidate had knowledge of  
4 44 it and failed to file a statement of disavowal with  
4 45 the commissioner or board and take corrective action  
4 46 within seventy-two hours of the action. A person,

5 25 reports indicating the dates on which the expenditures  
5 26 or incurrence of indebtedness took place; a  
5 27 description of the nature of the action taken which  
5 28 resulted in the expenditures or debt; and the cost of  
5 29 the promotion at fair market value. For a local  
5 30 ballot issue, the reports shall be filed five days  
5 31 prior to any election in which the ballot issue  
5 32 appears and on the first day of the month following  
5 33 the election, as well as on the nineteenth day of  
5 34 January, May, and July of each year in which the  
5 35 ballot issue appears on the ballot and on the  
5 36 nineteenth day of January and October of each year in  
5 37 which the ballot issue does not appear on the ballot.  
5 38 For a statewide ballot issue, reports shall be filed  
5 39 on the nineteenth day of January, May, and July of  
5 40 each year. The reports shall be current to five days  
5 41 prior to the filing deadline, and are considered  
5 42 timely filed if mailed bearing a United States postal  
5 43 service postmark on or before the due date. Filing  
5 44 obligations shall cease when the person files a  
5 45 statement of discontinuation indicating that the

7 9 organized pursuant to the laws of this state, the  
7 10 United States, or any other state, territory, or  
7 11 foreign country, whether for profit or not, or an  
7 12 officer, agent, or representative acting for such  
7 13 insurance company, savings and loan association, bank,  
7 14 credit union, or corporation, to contribute any money,  
7 15 property, labor, or thing of value, directly or  
7 16 indirectly, to a committee, or

8 14 corporation, as defined in section 9H.1, from placing  
8 15 a yard sign on agricultural land, and does not  
8 16 prohibit the placement of yard signs, with the prior  
8 17 written permission of the individual property owner,

8 18 on property rented or leased by a corporation from  
8 19 private individuals, subject to the requirements of  
8 20 section 56.14. This section also does not prohibit  
8 21 the placement of a yard sign on residential property  
8 22 that is owned by a corporation, but rented or leased  
8 23 to a private individual, if the prior permission of  
8 24 the renter or lessee is obtained.

8 25 Sec. 11. Section [56.15](#), Code 1999, is amended by  
8 26 adding the following new subsection:

8 27 NEW SUBSECTION. 4A. For purposes of this section,  
8 28 "committee" shall include statutory political  
8 29 committees organized under chapter 43, and nonparty  
8 30 political organizations organized under chapter 44.

8 31 Sec. 12. Section [56.22](#), subsection 2, Code 1999,  
8 32 is amended to read as follows:

8 33 2. Funds distributed to statutory political  
8 34 committees pursuant to this chapter shall not be used  
8 35 to

~~support or oppose~~

~~expressly advocate~~ the

8 36 nomination, election, or defeat of any candidate.

8 37 Nothing in this subsection shall be construed to  
8 38 prohibit a statutory political committee from using  
8 39 such funds to pay expenses incurred in arranging and  
8 40 holding a nominating convention.

8 41 Sec. 13. CAMPAIGN FINANCE COMMISSION. A campaign  
8 42 finance commission is established to study campaign  
8 43 finance disclosure and related laws and to recommend  
8 44 reforms in these laws, according to the following:

8 45 1. APPOINTMENT. The commission shall be composed  
8 46 of six members, bipartisan and gender-balanced in  
8 47 accordance with sections 69.16 and 69.16A, and  
8 48 appointed as follows:

8 49 a. Two members shall be the state chairs of each  
8 50 of the political parties, as defined in section 43.2,  
9 1 or their designees.

9 2 b. Four members shall be jointly appointed by the  
9 3 majority and minority leaders of the senate and house.  
9 4 These members shall be appointed from nonpartisan  
9 5 organizations which have researched, studied, and  
9 6 advocated the issue of political campaign finance  
9 7 reform for fifteen years or more, or who are specially  
9 8 qualified to serve on the commission because of  
9 9 training or experience.

9 10 c. The commission shall elect a chair and vice  
9 11 chair at its first meetings.

9 12 2. TERMS. The members of the commission shall  
9 13 serve for the life of the commission.

9 14 3. VACANCIES. A vacancy in the commission shall  
9 15 be filled in the manner in which the original  
9 16 appointment was made.

9 17 Sec. 14. POWERS AND DUTIES OF THE COMMISSION.

9 18 1. HEARINGS. The commission may hold hearings  
9 19 which shall be open and announced in advance to the  
9 20 public, take testimony, and receive evidence as the  
9 21 commission considers appropriate. Activities of the  
9 22 commission shall be held in accordance with chapter  
9 23 21.

9 24 The commission shall hold at least one hearing in  
9 25 each congressional district within the state  
9 26 specifically to obtain public input on the issue of  
9 27 campaign finance reform.

9 28 2. QUORUM. Four members of the commission shall  
9 29 constitute a quorum, but a lesser number may hold  
9 30 hearings.

9 31 3. REPORT. Not later than December 15, 1999, the

9 32 commission shall submit to the general assembly a  
9 33 report of the activities of the commission, together  
9 34 with a draft of legislation recommended by the  
9 35 commission to reform the campaign finance disclosure  
9 36 and related laws for consideration by the general  
9 37 assembly in the year 2000 according to the provisions  
9 38 of this Act.

9 39 4. MATTERS TO BE CONSIDERED. In holding hearings  
9 40 and preparing the report required under subsection 3,  
9 41 the commission shall consider all issues related to  
9 42 the reform of campaign finance disclosure and related  
9 43 laws. The commission may secure directly from any  
9 44 department or agency such information as the  
9 45 commission considers necessary, and the department or  
9 46 agency shall promptly furnish such information to the  
9 47 commission.

9 48 5. STAFFING. Assistance shall be provided to the  
9 49 commission by the central nonpartisan legislative  
9 50 staff bureaus. The commission may utilize the  
10 1 services of the legislative service bureau in  
10 2 formulating a draft of legislation. The attorney  
10 3 general's office and the ethics and campaign  
10 4 disclosure board shall serve as consultants, and  
10 5 advise the commission as necessary.

10 6 Sec. 15. ASSIGNMENT OF LEGISLATION. The  
10 7 legislation drafted by the commission shall be filed  
10 8 with each chamber on the first day of the legislative  
10 9 session beginning in the year 2000, and immediately  
10 10 assigned to the committee on state government in each  
10 11 chamber.

10 12 Sec. 16. TERMINATION. The commission shall cease  
10 13 to exist one month after the submission of its report.

10 14 Sec. 17. EFFECTIVE DATE. This Act, being deemed  
10 15 of immediate importance, takes effect upon enactment.

10 16 Sec. 18. SEVERABILITY. If any section of this  
10 17 Act, or any portion of any section of this Act, is  
10 18 found unconstitutional or otherwise unenforceable by a  
10 19 court, the remaining sections and portions of sections  
10 20 shall be given effect to the fullest extent possible."
