2 22 assembly with one member designated by each of the
2 23 following: the majority leader of the senate, the
2 24 minority leader of the senate, the speaker of the
2 25 house of representatives, and the minority leader of
2 26 the house of representatives. A legislative member
2 27 serves in an ex officio, nonvoting capacity and is
2 28 eligible for per diem and expenses as provided in
2 29 section 2.10.
