A person who is not the assembler, designer, or 1 10 manufacturer, and who wholesales, retails, 1 11 distributes, or otherwise sells a product is: a. Immune from any suit based upon strict 1 12 1 13 liability in tort or breach of implied warranty of 1 14 merchantability which arises solely from an alleged 1 15 defect in the original design or manufacture of the 1 16 product but only if the assembler, designer, or 17 manufacturer is either domiciled in the United States 18 or is subject to the jurisdiction of the courts of 1 19 this state and has not been judicially declared <u>20 insolvent</u>. 1 21 b. Not liable for damages based upon strict 1 22 liability in tort or breach of implied warranty of 1 23 merchantability for the product upon proof that the 1 24 <u>assembler</u>, <u>designer</u>, <u>or</u> manufacturer is <u>domiciled in</u> 1 25 the United States or is subject to the jurisdiction of 1 26 the courts of this state and has not been judicially 1 27 declared insolvent. 1 2.8 2. A person who is a retailer of a product and who 1 29 assembles a product, such assembly having no causal 1 30 relationship to the injury from which the claim 1 31 arises, is not liable for damages based upon strict 1 32 liability in tort or breach of implied warranty of 1 33 merchantability which arises from an alleged defect in 1 34 the original design or manufacture of the product upon 35 proof that the assembler, designer, or manufacturer is 1 1 36 domiciled in the United States or is subject to the jurisdiction of the courts of this state and has not 1 37 1 38 been judicially declared insolvent. 1 39 3. An action brought pursuant to this section, 1 40 where the claimant certifies that the assembler, 41 designer, or manufacturer of the product is not yet 1 42 identifiable, tolls the statute of limitations against 1 43 such assembler, designer, or manufacturer until such 1 44 time as discovery in the case has identified the 1 45 <u>assembler</u>, <u>designer</u>, <u>or</u> manufacturer. 4.
