1 2 #1. Page 34, by inserting after line 28, the
1 3 following:
1 4 . Section 321.109, subsection 1,
1 5 unnumbered paragraph 1, Code 2003, is amended to read
1 6 as follows:
1 7 The annual fee for all motor vehicles, including
1 8 vehicles designated by manufacturers as station
1 9 wagons, and ~~1993 and subsequent model years for~~
1 10 multipurpose vehicles, except motor trucks, motor
1 11 homes, ambulances, hearses, motorcycles, and motor
1 12 bicycles, ~~and 1992 and older model years for~~
~~1 13 multipurpose vehicles,~~ shall be equal to one percent
1 14 of the value as fixed by the department plus forty
1 15 cents for each one hundred pounds or fraction thereof
1 16 of weight of vehicle, as fixed by the department. The
1 17 weight of a motor vehicle, fixed by the department for
1 18 registration purposes, shall include the weight of a
1 19 battery, heater, bumpers, spare tire, and wheel.
1 20 Provided, however, that for any new vehicle purchased
1 21 in this state by a nonresident for removal to the
1 22 nonresident's state of residence the purchaser may
1 23 make application to the county treasurer in the county
1 24 of purchase for a transit plate for which a fee of ten
1 25 dollars shall be paid. And provided, however, that
1 26 for any used vehicle held by a registered dealer and
1 27 not currently registered in this state, or for any
1 28 vehicle held by an individual and currently registered
1 29 in this state, when purchased in this state by a
1 30 nonresident for removal to the nonresident's state of
1 31 residence, the purchaser may make application to the
1 32 county treasurer in the county of purchase for a
1 33 transit plate for which a fee of three dollars shall
1 34 be paid. The county treasurer shall issue a
1 35 nontransferable certificate of registration for which
1 36 no refund shall be allowed; and the transit plates
1 37 shall be void thirty days after issuance. Such
1 38 purchaser may apply for a certificate of title by
1 39 surrendering the manufacturer's or importer's
1 40 certificate or certificate of title, duly assigned as
1 41 provided in this chapter. In this event, the
1 42 treasurer in the county of purchase shall, when
1 43 satisfied with the genuineness and regularity of the
1 44 application, and upon payment of a fee of ten dollars,
1 45 issue a certificate of title in the name and address
1 46 of the nonresident purchaser delivering the same to
1 47 the person entitled to the title as provided in this
1 48 chapter. ~~The provisions of this subsection relating~~

2 5 a, Code 2003, is amended to read as follows:
2 6 a. If a 1993 model year or older motor vehicle,
~~2 7 other than a multipurpose vehicle,~~ has been titled in
2 8 the same person's name since the vehicle was new or
2 9 the title to the vehicle was transferred prior to
2 10 January 1, 2002, the part of the registration fee that
2 11 is based on the value of the vehicle shall be ten
2 12 percent of the rate as fixed when the motor vehicle
2 13 was new.
2 14 Sec. . Section 321.113, subsection 5, paragraph
2 15 b, unnumbered paragraph 1, Code 2003, is amended to
2 16 read as follows:
2 17 If the title of a 1993 model year or older motor
2 18 vehicle is transferred to a new owner or if such a
2 19 motor vehicle is brought into the state on or after
2 20 January 1, 2002, or if a vehicle is a 1993 model year
~~2 21 or older multipurpose vehicle,~~ the registration fee
2 22 shall not be based on the weight and list price of the
2 23 motor vehicle, but shall be as follows:
