1 5 Equal Number of Elected Party Members in Senate
1 6 If the senate has an equal number of elected party
1 7 members, all references in these rules to powers and
1 8 duties of the president shall apply to powers and
1 9 duties to be shared equally by the two co-presidents
1 10 and all references in these rules to powers and duties
1 11 of the majority and minority leaders shall apply to
1 12 powers and duties to be shared equally by the two co=
1 13 floor leaders.
1 14 Notwithstanding the provisions of joint rule 13,
1 15 subsection 1, relating to the number of senate members
1 16 of conference committees and the appointing
1 17 authorities for those members, if the senate has an
1 18 equal number of elected party members, the two co=
1 19 floor leaders, after consultation with the two co=
1 20 presidents, shall jointly appoint six members to
1 21 conference committees created pursuant to joint rule
1 22 13.>
