1 5 SERVICES FOR CITIES.
1 6 1. The department shall maintain a driver's
1 7 license issuance site within the corporate limits of a
1 8 city, which shall be open a minimum of five days per
1 9 week for the issuance and renewal of noncommercial
1 10 driver's licenses and permits, other than class M
1 11 driver's licenses, and nonoperator's identification
1 12 cards.
1 13 2. For purposes of this section, "city" means a
1 14 city with a population in excess of one hundred fifty
1 15 thousand according to the most recent federal
1 16 decennial census.>
