1 17 shall meet all of the following requirements:
1 18 (a) The program shall be a statewide mentoring
1 19 program that is an alternative to mentoring programs
1 20 that utilize the standards of effective practice.
1 21 (b) The program shall contract with a university
1 22 to assist in curriculum development and performance
1 23 evaluation.
1 24 (c) The program shall provide for some level of
1 25 public-private partnership.
1 26 (d) The program shall obtain the assistance of the
1 27 Iowa department of public health in the development of
1 28 the performance evaluation design.
1 29 (e) The program shall demonstrate improvement in
1 30 meeting current standards.
1 31 (2) The Iowa department of public health shall
1 32 negotiate a sole source contract with a nonprofit
1 33 corporation that mentors through live music and
1 34 receives funds through private partnership to
1 35 implement this paragraph "i".
1 36 (3) The Iowa department of public health may use
1 37 up to \$50,000 of the moneys appropriated under this
1 38 paragraph "i" to provide technical assistance to and
1 39 monitoring of the program.
1 40 (4) Notwithstanding section 8.33, moneys
1 41 appropriated under this paragraph "i" that remain
1 42 unencumbered or unobligated at the close of the fiscal
1 43 year shall not revert but shall remain available for
1 44 the purpose designated in the succeeding fiscal year.>
