1 19 b. For rent payments for the community-based  
1 20 corrections facility located in Davenport and the Vine  
1 21 street building located in West Des Moines:  
1 22 ..... \$ 122,000  
1 23 2. DEPARTMENT OF CULTURAL AFFAIRS  
1 24 For continuation of the project recommended by the  
1 25 Iowa battle flag advisory committee to stabilize the  
1 26 condition of the battle flag collection:  
1 27 ..... \$ 220,000  
1 28 3. DEPARTMENT OF EDUCATION  
1 29 To the vocational rehabilitation division to  
1 30 replace lost indirect costs:  
1 31 ..... \$ 101,164  
1 32 4. DEPARTMENT OF PUBLIC SAFETY  
1 33 For capitol building and judicial building  
1 34 security:

2 4 a. For the fiscal year beginning July 1, 2005, and  
2 5 ending June 30, 2006, the sum of fifteen million  
2 6 dollars.  
2 7 b. For the fiscal year beginning July 1, 2006, and  
2 8 ending June 30, 2007, the sum of fifteen million  
2 9 dollars.  
2 10 c. For the fiscal year beginning July 1, 2007, and  
2 11 ending June 30, 2008, the sum of fifty million  
2 12 dollars.  
2 13 d. For the fiscal year beginning July 1, 2008, and  
2 14 ending June 30, 2009, the sum of fifty million  
2 15 dollars.>

2 21 <Sec. \_\_\_\_\_. DEPARTMENT OF ADMINISTRATIVE SERVICES.  
2 22 1. There is appropriated from the vertical  
2 23 infrastructure fund to the department of  
2 24 administrative services for the designated fiscal

2 25 years, the following amounts, or so much thereof as if  
2 26 necessary, to be used for the purposes designated:

2 27 For major renovation and major repair needs,  
2 28 including health, life, and fire safety needs, and for  
2 29 compliance with the federal Americans With  
2 30 Disabilities Act, for state buildings and facilities  
2 31 under the purview of the department:

2 32 FY 2006=2007.....	\$ 10,000,000
2 33 FY 2007=2008.....	\$ 40,000,000
2 34 FY 2008=2009.....	\$ 40,000,000

2 35 Notwithstanding section 8.33, moneys appropriated  
2 36 in this section shall not revert at the close of the  
2 37 fiscal year for which they were appropriated but shall  
2 38 remain available for the purposes designated until the  
2 39 close of the fiscal year that begins July 1, 2010, or  
2 40 until the project for which the appropriation was made  
2 41 is completed, whichever is earlier.>>
