1 1 Amend House File 2459 as follows:  
1 2 #1. Page 5, by inserting after line 18 the  
1 3 following:  
1 4 <Sec. \_\_\_\_\_. MAINSTREET PROGRAM. There is  
1 5 appropriated from the federal economic stimulus and  
1 6 jobs holding fund to the department of economic  
1 7 development for the fiscal year beginning July 1,  
1 8 2006, and ending June 30, 2007, the following amount,  
1 9 or so much thereof as is necessary, for purposes of  
1 10 the mainstreet program, and for not more than the  
1 11 following full-time equivalent positions:  
1 12 ..... \$ 200,000  
1 13 ..... FTEs 1.50

1 14 The moneys appropriated in this section shall be in  
1 15 addition to, and not in lieu of, moneys appropriated  
1 16 to the department for purposes of the mainstreet  
1 17 program under section 2 of this Act.

1 18 Notwithstanding section 8.33, moneys appropriated  
1 19 in this section that remain unencumbered or  
1 20 unobligated at the close of the fiscal year shall not  
1 21 revert but shall remain available for expenditure for  
1 22 the purposes designated until the close of the  
1 23 succeeding fiscal year.>
