1 3 following:
1 4 <Section 1. Section 99F.15, subsection 1,
1 5 paragraphs a and b, Code 2005, are amended to read as
1 6 follows:
1 7 a. Operating a gambling excursion or racetrack
1 8 enclosure where wagering is used or to be used without
1 9 a license issued by the commission.
1 10 b. Operating a gambling excursion or racetrack
1 11 enclosure where wagering is permitted other than in
1 12 the manner specified by section 99F.9.
1 13 Sec. _____. Section 99F.15, subsection 4, unnumbered
1 14 paragraph 1, Code 2005, is amended to read as follows:
1 15 A person commits a class "D" felony and, in
1 16 addition, shall be barred for life from excursion
1 17 gambling boats and racetrack enclosures conducting
1 18 gambling games under the jurisdiction of the
1 19 commission, if the person does any of the following:
1 20 Sec. _____. Section 99F.15, subsection 4, paragraphs
1 21 a and b, Code 2005, are amended to read as follows:
1 22 a. Offers, promises, or gives anything of value or
1 23 benefit to a person who is connected with an excursion
1 24 gambling boat or racetrack enclosure operator
1 25 including, but not limited to, an officer or employee
1 26 of a licensee or holder of an occupational license
1 27 pursuant to an agreement or arrangement or with the
1 28 intent that the promise or thing of value or benefit
1 29 will influence the actions of the person to whom the
1 30 offer, promise, or gift was made in order to affect or
1 31 attempt to affect the outcome of a gambling game, or
1 32 to influence official action of a member of the
1 33 commission.
1 34 b. Solicits or knowingly accepts or receives a
1 35 promise of anything of value or benefit while the
1 36 person is connected with an excursion gambling boat or
1 37 racetrack enclosure including, but not limited to, an
1 38 officer or employee of a licensee, or holder of an
1 39 occupational license, pursuant to an understanding or
1 40 arrangement or with the intent that the promise or
1 41 thing of value or benefit will influence the actions
1 42 of the person to affect or attempt to affect the
1 43 outcome of a gambling game, or to influence official
1 44 action of a member of the commission.>

1 46 inserting the following: <An Act relating to criminal
1 47 penalties for violations committed by personnel and
1 48 agents of the department of corrections and judicial
1 49 district department of correctional services and at
1 50 racetrack enclosures conducting casino games, and to
