1 2 as amended, passed, and reprinted by the Senate, as
1 3 follows:
1 4 #1. Page 1, by striking lines 6 through 10 and
1 5 inserting the following:

1 7 word <veterans.> the following: <Providing grants to
1 8 eligible injured veterans pursuant to this section is
1 9 deemed to serve a vital and valid public purpose of
1 10 the state by assisting injured veterans and their
1 11 families.>

1 13 following:
1 14 <2A. The department may receive and accept
1 15 donations, grants, gifts, and contributions from any
1 16 public or private source for the purpose of providing
1 17 grants under this section. Moneys received by the
1 18 department pursuant to this subsection shall be
1 19 deposited in an injured veterans trust fund which
1 20 shall be created in the state treasury under the
1 21 control of the department. Moneys credited to the
1 22 trust fund shall be appropriated to the department for
1 23 the purpose of providing injured veterans grants under
1 24 this section and shall not be transferred, used,
1 25 obligated, appropriated, or otherwise encumbered,
1 26 except as provided in this section. Notwithstanding
1 27 section 12C.7, subsection 2, interest or earnings on
1 28 moneys in the trust fund shall be credited to the
1 29 trust fund.>>

1 41 under the injured veterans grant program established
1 42 in section 35A.14. Amounts subtracted under this
1 43 subsection shall not be used by the taxpayer in
1 44 computing the amount of charitable contributions as
1 45 defined by section 170 of the Internal Revenue Code.>
