1 1 Amend Senate File 71 as follows:  
1 2 #1. Page 1, by inserting before line 1, the  
1 3 following:  
1 4 <Sec. \_\_\_\_\_. NEW SECTION. 170.3A CHRONIC WASTING  
1 5 DISEASE CONTROL PROGRAM == FEES.  
1 6 1. The department shall establish and administer a  
1 7 chronic wasting disease control program for the  
1 8 control of chronic wasting disease which threatens  
1 9 farm deer. The program may include procedures for the  
1 10 inspection and testing of farm deer, responses to  
1 11 reported cases of chronic wasting disease, and methods  
1 12 to ensure that owners of farm deer may engage in the  
1 13 movement and sale of farm deer.  
1 14 2. Beginning on July 1, 2006, a chronic wasting  
1 15 disease control fee is imposed on landowners who  
1 16 maintain farm deer in this state. The fee shall be  
1 17 established by rules adopted by the department in an  
1 18 amount which will generate total revenue not exceeding  
1 19 an amount which is reasonable and necessary to  
1 20 administer the chronic wasting disease control  
1 21 program.  
1 22 Sec. \_\_\_\_\_. NEW SECTION. 170.3B FARM DEER  
1 23 ADMINISTRATION FUND == APPROPRIATION.  
1 24 1. A farm deer administration fund is created in  
1 25 the state treasury under the control of the  
1 26 department. The fund is composed of moneys  
1 27 appropriated by the general assembly and moneys  
1 28 available to and obtained or accepted by the  
1 29 department from the United States or private sources  
1 30 for placement in the fund. The fund shall include all  
1 31 moneys collected from the chronic wasting disease  
1 32 control fee as provided in section 170.3A. The moneys  
1 33 in the fund are appropriated exclusively to the  
1 34 department for purposes of administering the chronic  
1 35 wasting disease control program as provided in section  
1 36 170.3A.  
1 37 2. Moneys in the fund are subject to an annual  
1 38 audit by the auditor of state. The fund is subject to  
1 39 warrants written by the director of the department of  
1 40 administrative services, drawn upon the written  
1 41 requisition of the department.  
1 42 3. Section 8.33 shall not apply to moneys in the  
1 43 fund. Notwithstanding section 12C.7, moneys earned as  
1 44 income or interest from the fund shall remain in the  
1 45 fund until expended as provided in this section.>  
1 46 #2. Page 1, by inserting after line 12, the  
1 47 following:  
1 48 <( ) Of the amount appropriated in this  
1 49 paragraph "f", \$127,000 shall be deposited into the  
1 50 farm deer administration fund created in section  
2 1 170.3B for purposes of administering the chronic  
2 2 wasting disease control program as provided in section  
2 3 170.3A.>
