1 1 Amend House File 591, as amended, passed, and
1 2 reprinted by the House, as follows:
1 3 #1. Page 2, by inserting after line 18 the
1 4 following:
1 5 <Sec. _____. NEW SECTION. 321.197 PEACE CORPS
1 6 SERVICE EXCEPTION.
1 7 1. The effective date of a valid driver's license
1 8 issued in this state, held by a person at the
1 9 beginning of the person's period of service as a
1 10 volunteer in the federal peace corps program
1 11 established in 22 U.S.C. } 2501=2523, notwithstanding
1 12 the expiration of the license according to its terms,
1 13 shall be extended without fee until six months
1 14 following the date of the person's termination of
1 15 service as a volunteer in the peace corps, provided
1 16 the person is not suffering from physical disabilities
1 17 which impair the person's competency as an operator
1 18 and provided further that the licensee shall furnish a
1 19 description of service document upon demand of any
1 20 peace officer. However, a person entitled to the
1 21 benefits of this section who is charged with operating
1 22 a motor vehicle without a driver's license shall not
1 23 be convicted if the person produces in court, within a
1 24 reasonable time, a valid driver's license previously
1 25 issued to that person along with the person's
1 26 description of service document.
1 27 2. The department is authorized to renew any
1 28 driver's license falling within the provisions and
1 29 limitations of subsection 1 without examination, upon
1 30 application and payment of fee made within six months
1 31 following the person's termination of service as a
1 32 peace corps volunteer.
1 33 3. A person whose period of license validity is
1 34 extended under this section may file an application in
1 35 accordance with rules adopted by the department to
1 36 have the person's record of issuance of a driver's
1 37 license retained in the department's record system
1 38 during the period for which the driver's license
1 39 remains valid. If the record of issuance of the
1 40 person's driver's license has been removed from the
1 41 department's records, the department shall reenter the
1 42 person's record of driver's license issuance upon
1 43 request of the person if the request is accompanied by
1 44 the person's description of service document.
1 45 4. As used in this section, "description of
1 46 service document" means the official written statement
1 47 issued by the peace corps, or an official copy of the
1 48 statement, which describes a person's peace corps
1 49 service and includes the dates of such service. The
1 50 department may, in its discretion, accept other
2 1 evidence of a person's dates of service provided by
2 2 the peace corps office of return volunteer services in
2 3 lieu of the description of service document.>

2 5 word <restrictions,> the following: <driver's license
2 6 renewal,>.
