

# Senate Amendment 3096

1 1 Amend Senate File 206, as amended, passed, and  
1 2 reprinted by the Senate, as follows:  
1 3 #1. Page 1, by striking lines 1 through 14.  
1 4 #2. Page 1, by striking lines 15 through 19.  
1 5 #3. Page 2, lines 18 and 19, by striking the words  
1 6 <deer herd population management, including>.  
1 7 #4. Page 2, line 27, by striking the words <deer  
1 8 herd population management, including>.  
1 9 #5. Page 3, line 32, by striking the words  
1 10 <purpose of deer herd population management> and  
1 11 inserting the following: <help us stop hunger  
1 12 program>.  
1 13 #6. Page 4, by striking lines 11 through 17 and  
1 14 inserting the following: <information pursuant to  
1 15 this section. Information collected by the commission  
1 16 pursuant to the deer harvest reporting system from a  
1 17 deer hunter who takes a deer shall be limited to the  
1 18 following:  
1 19 a. The county where the deer was taken.  
1 20 b. The season during which the deer was taken.  
1 21 c. The sex of the deer taken.  
1 22 d. The age of the deer taken.  
1 23 e. The type of weapon used.  
1 24 f. The hunting license number of the hunter.  
1 25 g. The number of days the hunter hunted.  
1 26 h. The total number of deer taken by the hunter.  
1 27 2. The deer harvest reporting system established  
1 28 by the commission shall utilize and is limited to  
1 29 utilizing one or more of the following methods of  
1 30 reporting deer taken by hunters:  
1 31 a. A toll-free telephone number.  
1 32 b. A postcard.  
1 33 c. Reporting at an electronic licensing location.  
1 34 d. Electronic internet communication.>  
1 35 #7. Page 4, line 23, by striking the word <ten>  
1 36 and inserting the following: <two>.  
1 37 #8. Page 4, by striking lines 29 through 31.  
1 38 #9. Page 6, by inserting after line 21, the  
1 39 following:  
1 40 <Sec. \_\_\_\_\_. Section 483A.24, subsection 2, Code  
1 41 2005, is amended by adding the following new  
1 42 paragraph:  
1 43 NEW PARAGRAPH. f. A deer hunting license or wild  
1 44 turkey hunting license issued pursuant to this  
1 45 subsection shall be attested by the signature of the  
1 46 person to whom the license is issued and shall contain  
1 47 a statement in substantially the following form:  
1 48 By signing this license I certify that I qualify as  
1 49 an owner or tenant under Iowa Code section 483A.24.  
1 50 A person who makes a false attestation as described  
2 1 in this paragraph is guilty of a simple misdemeanor.  
2 2 In addition, the person's hunting license shall be  
2 3 revoked and the person shall not be issued a hunting  
2 4 license for a period of one year.>  
2 5 #10. Page 6, by striking lines 22 through 29 and  
2 6 inserting the following:  
2 7 <Sec. \_\_\_\_\_. NEW SECTION. 483A.24B SPECIAL DEER  
2 8 HUNTS.  
2 9 1. The commission may establish a special season  
2 10 deer hunt for antlerless deer in those counties where  
2 11 paid antlerless only deer hunting licenses remain  
2 12 available for issuance.  
2 13 2. Antlerless deer may be taken by shotgun,  
2 14 muzzleloading rifle, muzzleloading pistol, handgun, or  
2 15 bow during the special season as provided by the  
2 16 commission by rule.  
2 17 3. Prior to December 15, a resident may obtain up  
2 18 to three paid antlerless only deer hunting licenses  
2 19 for the special season regardless of how many paid or  
2 20 free gun or bow deer hunting licenses the person may  
2 21 have already obtained. Beginning December 15, a  
2 22 resident or nonresident may purchase an unlimited  
2 23 number of antlerless only deer hunting licenses for  
2 24 the special season. Notwithstanding section 483A.1,

2 25 the fee for an antlerless only deer hunting license  
2 26 issued pursuant to this section shall be ten dollars  
2 27 for residents.  
2 28 4. All antlerless deer hunting licenses issued  
2 29 pursuant to this section shall be included in the  
2 30 quotas established by the commission by rule for each  
2 31 county and shall be available in each county only  
2 32 until the quota established by the commission for that  
2 33 county is filled.  
2 34 5. The daily bag and possession limit during the  
2 35 special season is one deer per license. The tagging  
2 36 requirements are the same as for the regular gun  
2 37 season.  
2 38 6. A person who receives a license pursuant to  
2 39 this section shall be otherwise qualified to hunt deer  
2 40 in this state and shall have a hunting license and pay  
2 41 the wildlife habitat fee.  
2 42 7. A person violating a provision of this section  
2 43 or a rule adopted pursuant to this section is guilty  
2 44 of a simple misdemeanor punishable as a scheduled  
2 45 violation as provided in section 483A.42.>
