1 7 inserting the following: <including the preparation
1 8 of documents relating to space planning, finish
1 9 materials, furnishings, fixtures, and equipment, and
1 10 the preparation of documents relating to interior
1 11 construction that does not affect the mechanical or
1 12 structural systems of a building. "Interior">
1 13 #3. Page 1, by striking lines 18 through 21 and
1 14 inserting the following: <registered under this
1 15 chapter.>
1 16 #4. Page 2, line 22, by inserting after the word
1 17 <duties.> the following: <The rules shall include
1 18 provisions addressing conflicts of interest and full
1 19 disclosure, including sources of compensation.>
1 20 #5. Page 3, by striking lines 22 through 27 and
1 21 inserting the following:
1 22 <2. Has completed any of the following:
1 23 a. Four years of interior design education plus
1 24 two years of full-time work experience in interior
1 25 design.
1 26 b. Three years of interior design education plus
1 27 three years of full-time work experience in interior
1 28 design.
1 29 c. Two years of interior design education plus
1 30 four years of full-time work experience in interior

1 32 #6. Page 6, by striking lines 3 through 10 and
1 33 inserting the following:
1 34 <1. A person licensed to practice architecture
1 35 pursuant to the laws of this state.
1 36 2. A person licensed as a professional engineer
1 37 pursuant to the laws of this state.>
1 38 #7. Page 6, by striking lines 23 through 28.
1 39 #8. By striking page 6, line 32 through page 7,
1 40 line 8 and inserting the following: <interior
1 41 designer to a person residing in Iowa who does not
1 42 meet the examination requirements specified in section
1 43 544C.5, if the person submits evidence to the board
1 44 demonstrating both of the following:
1 45 1. A minimum of two years of interior design
1 46 education and a combined total of six years of
1 47 interior design education and experience that is
1 48 acceptable to the board.
1 49 2. Successful completion of section 1 of the
1 50 national council for interior design qualification
2 1 examination relating to life safety codes and barrier=
2 2 free requirements.>
