2 4 <Sec. _____. DEPARTMENT OF EDUCATION. There is
2 5 appropriated from the healthy Iowans tobacco trust
2 6 created in section 12.65, to the department of
2 7 education for the fiscal year beginning July 1, 2006,
2 8 and ending June 30, 2007, the following amount, or so
2 9 much thereof as is necessary, to be used for the
2 10 purpose designated:
2 11 To establish a competitive grants program to expand
2 12 the availability of before and after school programs:
2 13 \$ 150,000
2 14 School districts and other public and private
2 15 organizations shall be eligible to apply for a grant
2 16 from the program. Grant applications shall be
2 17 assessed by the department based on the targeted
2 18 student population and whether the application
2 19 demonstrates partnerships and collaboration with
2 20 not-for-profit community organizations, if
2 21 appropriate; indicates that the school district or
2 22 organization has access to training for the program;
2 23 provides for a safe and engaging environment; combines
2 24 academic, enrichment, cultural, and recreational

2 25 activities; provides for no less than a 20 percent
2 26 match; and demonstrates that the school district or
2 27 organization is able to sustain the program after the
2 28 grant is exhausted. The types of activities supported
2 29 by an applicant may include but are not limited to
2 30 tutoring and supplementing instruction in basic
2 31 skills, such as reading, math, and science; drug and
2 32 violence prevention curricula and counseling; youth
2 33 leadership activities; volunteer and service learning
2 34 opportunities; career and vocational awareness
2 35 preparation; courses and enrichment in arts and
2 36 culture; computer instruction; character development
2 37 and civic participation; language instruction,
2 38 including English as a second language; mentoring;
2 39 positive interaction with law enforcement; supervised
2 40 recreation programs; or health and nutrition programs.
2 41 The department shall make every attempt to leverage
2 42 additional funding from other public and private
2 43 sources to support the program provided under this
2 44 section.>

2 45 #21. Page 10, by inserting after line 15 the
2 46 following:

2 47 <Sec. ____ FARMERS WITH DISABILITIES == FEDERAL
2 48 REPLACEMENT FUNDS. There is appropriated from the
2 49 general fund of the state to the division of
2 50 vocational rehabilitation services of the department
3 1 of education for the fiscal year beginning July 1,
3 2 2006, and ending June 30, 2007, the following amount,
3 3 or so much thereof as is necessary, to be used for the
3 4 purpose designated:

3 5 For a grant to a national nonprofit organization
3 6 with over 80 years of experience in assisting children
3 7 and adults with disabilities and special needs and
3 8 their families through services that include medical
3 9 rehabilitation, job training and employment services,
3 10 child care, adult day services, and camping and
3 11 recreation, in order to replace expired federal
3 12 funding for a nationally recognized program that has
3 13 been replicated in 30 other states but which is not
3 14 available through any other entity in this state that
3 15 provides assistance to farmers with disabilities in
3 16 all 99 counties to allow the farmers to remain in
3 17 their own homes and be gainfully engaged in farming
3 18 through provision of agricultural worksite and home
3 19 modification consultations, peer support services,
3 20 services to families, information and referral, and
3 21 equipment loan services:

3 23 Sec. ____ Section 135.26, Code Supplement 2005, is
3 24 amended to read as follows:

3 25 135.26 AUTOMATED EXTERNAL DEFIBRILLATOR GRANT
3 26 PROGRAM.

3 27 The department shall establish and implement an
3 28 automated external defibrillator grant program which
3 29 provides matching funds to local boards of health,
3 30 community organizations, or cities for the program
3 31 after standards and requirements for the utilization
3 32 of automated external defibrillator equipment, and
3 33 training on the use of such equipment, are developed
3 34 at the local level. The objective of the program
3 35 shall be to enhance the emergency response system in
3 36 rural areas of the state where access to health care
3 37 providers is often limited by providing increased
3 38 access to automated external defibrillator equipment
3 39 by rural emergency and community personnel. A local
3 40 board of health, community organization, or city may
3 41 submit an application to the department for review.
3 42 The department shall establish criteria for the review
3 43 and approval of grant applications by rule, and may
3 44 accept gifts, grants, bequests, and other private
3 45 contributions, as well as state or federal funds, for
3 46 purposes of the program. The amount of a grant shall
3 47 not exceed fifty percent of the cost of the automated
3 48 external defibrillator equipment to be distributed to
3 49 the applicant and the training program to be
3 50 administered by the applicant at the local level.

4 1 Each application shall include information
4 2 demonstrating that the applicant will provide matching
4 3 funds of fifty percent of the cost of the program.
4 4 Grant recipients shall submit an annual report to the
4 5 department indicating automated external defibrillator

4 6 equipment usage levels, patient outcomes, and number
4 7 of individuals trained. For the purposes of this
4 8 section, "rural" means a geographic area outside an
4 9 urban or suburban setting with a population of less
4 10 than fifty thousand persons.

4 11 Sec. _____. 2005 Iowa Acts, chapter 176, section 1,
4 12 subsection 1, paragraph a, unnumbered paragraph 2, is
4 13 amended to read as follows:

4 14 Of the amount appropriated in this paragraph,
4 15 ~~\$50,000~~ \$150,000 shall be used to continue the efforts
4 16 of the Iowa chronic care consortium pursuant to 2003
4 17 Iowa Acts, chapter 112, section 12, as amended by 2003
4 18 Iowa Acts, chapter 179, sections 166 and 167.>
