Obtain, possess, or have in the person's 21 control or on the person's premises, a driver's 22 license or a nonoperator's identification card, or 23 blank driver's license or nonoperator's identification 24 card form, or any other form or document which could 25 be used to establish a person's identity, which has 26 been made by a person having no authority or right to 27 make the license, card, or form in order to assist an 28 unauthorized alien to obtain employment. 4.
