1 16 November 1, 2008, and continuing thereafter, the  
1 17 commissioner shall, from time to time, convene  
1 18 representatives of health insurers and health care  
1 19 providers licensed under chapter 148, 150, or 150A, to  
1 20 discuss and make recommendations about issues relating  
1 21 to cost containment, quality, and access of health  
1 22 care for Iowans, with a focus on major factors and  
1 23 trends in health care. The commissioner may identify  
1 24 procedures or practices related to health insurance  
1 25 that merit regulatory intervention or direction by the  
1 26 commissioner and shall take action as deemed  
1 27 appropriate within the commissioner's authority. The  
1 28 commissioner may make recommendations to the general  
1 29 assembly and the governor regarding legislation to  
1 30 improve the efficient and effective delivery of health  
1 31 care services and to strengthen the private health  
1 32 insurance market in this state.>>
