OF 2009 == PROPERTY TAX RELIEF FUND RISK POOL.
1. There is appropriated from the fund created by
section 8.41 to the department of human services for
the fiscal year beginning July 1, 2008, and ending
June 30, 2009, the following amount, or so much
thereof as is necessary, to be used for the purposes
designated:
From unencumbered fiscal stabilization moneys
available under the American Recovery and Reinvestment
Act of 2009, to be credited to the risk pool created
in the property tax relief fund in section 426B.5:
..................................................... \$ 14,000,000
2. The amount appropriated in this section shall
be used for grants to counties to eliminate or avoid
the implementation of waiting lists in the fiscal year
beginning July 1, 2008, and the succeeding fiscal
year, and to address the other circumstances the risk
pool' is authorized to address. All of the eligibility
requirements and other requirements and restrictions
applicable to risk pool funding under section 426B.5
are applicable for distribution of the moneys
appropriated in this section except for the following:
a. Notwithstanding section 426B.5, subsection 2,
paragraph "h", the risk pool board shall allocate the
moneys appropriated in this section so that the moneys
are distributed to counties for both the fiscal year
beginning July 1, 2008, and the succeeding fiscal
year.
b. Awards of the unpaid balances of the amounts
previously accepted by the risk pool board for award
for the fiscal year beginning July 1, 2008, shall be
made without additional application. For the
remainder of the appropriation, a county must apply
for risk pool assistance withín 30 calendar days of
the effective date of this section. The risk pool
board shall make its final decisions on applications
within 60 calendar days of the effective date of this
section.
3. The department of human services shall
calculate the amount of moneys due to eligible
counties in accordance with the board's decisions and
that amount is appropriated for each fiscal year from
the risk pool to the department for payment of the
moneys due. For the fiscal year beginning July 1,
2008, the department shall authorize the issuance' of
warrants payable to the county treasurer for the
amounts due and the warrants shall be issued on or
before June 15, 2009. For the succeeding fiscal year,
the department shall authorize the issuance of
warrants payable to the county treasurer for the
amounts due and the warrants shall be issued on or
before July 15, 2009.>
