1 8 1. In lieu of 2010 Iowa Acts, House File 2519,
1 9 section 19, if additional funding designated for
1 10 education stabilization is made available for the
1 11 fiscal year beginning July 1, 2010, through the state
1 12 fiscal stabilization fund established pursuant to the
1 13 federal American Recovery and Reinvestment Act of 2009,
1 14 Pub. L. No. 111=5, such funding shall be credited to
1 15 the federal recovery and reinvestment fund created in
1 16 section 8.41A and is appropriated for the fiscal year
1 17 beginning July 1, 2010, and ending June 30, 2011, to
1 18 the departments and agencies that received the funding
1 19 designated for education stabilization in 2009 Iowa
1 20 Acts, chapter 183, section 61, subsection 1.
1 21 2. a. Except as otherwise provided in paragraph
1 22 "b", the amounts of the individual appropriations made
1 23 in subsection 1 shall be in the same proportion as the
1 24 individual appropriations in 2009 Iowa Acts, chapter
1 25 183, section 61, subsection 1, bear to the total amount
1 26 appropriated in that provision.
1 27 b. (1) The amount appropriated pursuant to
1 28 subsection 1 for state foundation aid to schools shall
1 29 not exceed the difference between the amount determined
1 30 for the standing appropriation for state foundation
1 31 aid for the fiscal year pursuant to section 257.16,
1 32 subsection 1, and the amount the standing appropriation
1 33 was limited to pursuant to this division of this Act.
1 34 (2) The amount appropriated for the fiscal year
1 35 pursuant to subsection 1 for instructional support
1 36 state aid under section 257.20 shall not exceed
1 37 \$5,609,950, shall be in addition to the appropriation
1 38 made in this division of this Act for the same purpose
1 39 from the school infrastructure fund, and shall be
1 40 allocated as provided in the school infrastructure fund
1 41 appropriation.
1 42 3. a. Except as provided in subsection 2 for
1 43 instructional support state aid, the distribution of
1 44 each appropriation made pursuant to subsection 1 to
1 45 subunits of the departments and agencies shall also be
1 46 in the same proportion as the distribution to subunits
1 47 of the individual appropriations in 2009 Iowa Acts,
1 48 chapter 183, section 61, subsection 1. However, state
1 49 foundation aid to school districts shall be distributed
1 50 based on 2010 Iowa Acts, House File 2519, section 20,
2 1 subsection 1.
2 2 b. If good cause exists, as determined by
2 3 the departments of education and management, in
2 4 coordination with the office of the governor,
2 5 adjustments may be made to distribution proportions to
2 6 the subunits other than as provided in paragraph "a".
2 7 4. The department of management shall report to the
2 8 chairpersons and ranking members of the appropriations
2 9 committees of the senate and house of representatives
2 10 and the legislative services agency concerning any
2 11 appropriations and distributions made pursuant to this
2 12 section, within two weeks of such appropriations and
2 13 distributions being made. >>
