6 AND COUNCILS

7 Section 1. NEW SECTION. 2.69 Definitions.

8 As used in this subchapter, unless the context otherwise
9 requires:

10 1. "Board" means any board, commission, committee, council,
11 panel, review team, or foundation of this state.

12 2. "Committee" means the state government efficiency review
13 committee established pursuant to this subchapter.

14 Sec. 2. NEW SECTION. 2.70 Committee — duties.

15 1. The committee shall carry out the functions provided in
16 this subchapter.

17 2. Administrative assistance shall be provided by the
18 legislative services agency.

19 Sec. 3. NEW SECTION. 2.71 Board reviews.

20 1. The committee shall review the usefulness, performance,
21 and efficacy of each board as provided in subsection 2. The
22 committee shall hold hearings to receive the testimony of the
23 public, the chief executive officer of the board, and any other
24 person deemed necessary by the committee. After completing a
25 review, the committee shall prepare and publish a report of its
26 findings and recommendations as provided in section 2.72.

27 2. The committee shall establish a schedule for the
28 committee to review each board such that the committee reviews
29 approximately one-fourth of all boards each calendar year.
30 Each board shall be reviewed once between the calendar years
31 2025 and 2029, and once every four years thereafter. The
32 committee may modify the schedule as necessary to facilitate
33 the efficient administration of the committee.

34 3. A board that is scheduled for review shall submit a
35 report to the committee thirty days prior to the date that it

1 is scheduled for review that includes all of the following
2 information:

3 a. The board's primary purpose and its goals and objectives.

4 b. The board's past and anticipated workload, the number of
5 staff required to complete that workload, and the board's total
6 number of staff.

7 c. The board's past and anticipated budgets and its sources
8 of funding.

9 d. The number of members that compose the governing board or
10 other governing entity of the board and member compensation,
11 if any.

12 e. Any other information requested by the committee.

13 4. A board subject to review shall bear the burden of
14 demonstrating to the committee a public need for its continued
15 existence. In determining whether a board has met that
16 burden, the committee shall consider all of the following, as
17 applicable:

18 a. Whether continuation of the board is necessary to protect
19 the health or safety of the public, and if so, the manner in
20 which it is necessary and whether the board's authority is
21 narrowly tailored to protect against present, recognizable, and
22 significant harms to the health or safety of the public.

23 b. The extent to which the board's jurisdiction and programs
24 overlap or duplicate those of other boards, the extent to which
25 the board coordinates with those other boards, and the extent
26 to which the board's programs could be consolidated with the
27 programs of other state departments or boards.

28 c. Whether the operation of the board has inhibited economic
29 growth, reduced efficiency, or increased government costs.

30 d. The cost-effectiveness of the board in terms of the
31 number of employees, services rendered, and administrative
32 costs incurred, both past and present.

33 e. Whether the purpose for which the board was created has
34 been fulfilled, has changed, or no longer exists.

1 1. After completing a review of a board pursuant to section
2 2.71, the committee shall prepare and submit a report of its
3 findings and recommendations by December 21 of each year.
4 A report may include findings and recommendations for more

6 available on the general assembly's internet site.

7 2. Recommendations of the committee shall indicate how or
8 whether implementation of the recommendations would do each of
9 the following:

- 10 a. Improve efficiency in the management of state government.

21 1. A state government efficiency review committee is
22 established which shall meet as necessary to efficiently
23 review all boards according to the schedule established by the
24 committee pursuant to section 2.71.

25 2. a. (1) The committee shall consist of two members of
26 the senate appointed by the majority leader of the senate, one
27 member of the senate appointed by the minority leader of the
28 senate, two members of the house of representatives appointed
29 by the speaker of the house of representatives, and one member
30 of the house of representatives appointed by the minority
31 leader of the house of representatives.

32 (2) The following shall serve as ex officio, nonvoting
33 members of the committee:

34 (a) An employee of the office of the governor, appointed by
35 the governor.

1 (b) The director of the department of management or the
2 director's designee.

3 (c) The director of the department of inspections, appeals,
4 and licensing or the director's designee.

5 b. Members shall be appointed prior to January 31 of the
6 first regular session of each general assembly and shall serve

9 later. A vacancy shall be filled in the same manner as the
10 original appointment and shall be for the remainder of the
11 unexpired term of the vacancy.

15 reimbursed for actual and necessary expenses incurred in the
16 performance of their duties and shall be paid a per diem as
17 specified in section 2.10 for each day in which they engaged
18 in the performance of their duties. However, per diem
19 compensation and expenses shall not be paid to members of the
20 general assembly when the general assembly is actually in
21 session at the seat of government. Expenses and per diem shall
22 be paid from moneys appropriated pursuant to section 2.12.

23 4. Administrative assistance shall be provided by the
24 legislative services agency.

10 program, apprenticeship training program, on-the-job training
11 program or other occupational training or retraining program,
12 with the utilization of objective criteria in the admission of
13 individuals to such programs.

14 (3) Admission of individuals to a public accommodation or an
15 educational institution.

16 (4) Sale, exchange, lease, rental, assignment or sublease
17 of real property to an individual.

18 (5) Extension to all individuals of the full and equal
19 enjoyment of the advantages, facilities, privileges, and
20 services of the respondent denied to the complainant because of
21 the discriminatory or unfair practice.

22 (6) Reporting as to the manner of compliance.

23 (7) Posting notices in conspicuous places in the
24 respondent's place of business in form prescribed by the
25 ~~commission~~ agency and inclusion of notices in advertising
26 material.

27 (8) Payment to the complainant of damages for an injury
28 caused by the discriminatory or unfair practice which damages
29 shall include but are not limited to actual damages, court
30 costs and reasonable attorney fees.

31 (9) For an unfair or discriminatory practice relating
32 to wage discrimination pursuant to [section 216.6A](#), payment
33 to the complainant of damages for an injury caused by the
34 discriminatory or unfair practice which damages shall include
35 but are not limited to court costs, reasonable attorney fees,

1 and either of the following:

2 (a) An amount equal to two times the wage differential
3 paid to another employee compared to the complainant for the
4 period of time for which the complainant has been discriminated
5 against.

6 (b) In instances of willful violation, an amount equal to
7 three times the wage differential paid to another employee as
8 compared to the complainant for the period of time for which
9 the complainant has been discriminated against.

10 b. In addition to the remedies provided in the preceding
11 provisions of this subsection, the ~~commission~~ agency may issue
12 an order requiring the respondent to cease and desist from the
13 discriminatory or unfair practice and to take such affirmative
14 action as in the judgment of the ~~commission~~ agency will carry
15 out the purposes of this chapter as follows:

16 (1) In the case of a respondent operating by virtue of
17 a license issued by the state or a political subdivision
18 or agency, if the ~~commission~~ agency, upon notice to the
19 respondent with an opportunity to be heard, determines that the

35 or subcontract with the state or political subdivision or

1 agency, if the practice was authorized, requested, commanded,
2 performed, or knowingly or recklessly tolerated by the board
3 of directors of the respondent or by an officer or executive
4 agent acting within the scope of the officer's or agent's
5 employment, the ~~commission~~ agency shall so certify to the
