1 Amend Senate File 2109 as follows:

2 1. Page 4, line 14, by striking <activities.> and inserting
3 <activities, or from the applicant's primary instructor if the
4 applicant receives competent private instruction or independent
5 private instruction.>

6 2. Page 4, line 16, by striking <to a place of employment
7 unsupervised,> and inserting <unsupervised to a place of
8 employment or a location for farm-related work while employed
9 to work on a farm,>

10 3. Page 4, line 18, by striking <to work.> and inserting
11 <for such purposes.>

12 4. Page 4, line 20, by striking <employment.> and inserting
13 <employment, or primary farm location, as applicable.>

14 5. Page 5, line 11, by striking <place of employment,>
15 and inserting <location where the licensee receives competent
16 private instruction or independent private instruction, place
17 of employment, location for farm work or farm-related work if
18 the licensee resides on a farm or is employed for compensation
19 on a farm in this state,>

20 6. Page 5, line 19, by striking <or work shift,> and
21 inserting <work shift, farm work, or farm-related work,>

22 7. Page 5, line 25, after <activities.> by inserting <If
23 the licensee receives independent private instruction and
24 participates in an extracurricular activity at another school,
25 the licensee may drive to the location of the extracurricular
26 activity regardless of whether the licensee is enrolled at the
27 school.>

28 8. Page 5, after line 27 by inserting:

29 <(5) For the purpose of assisting the licensee's parents,
30 guardians, or employer with farm work or in connection with any
31 farm job, employment, or other farm-related work, including
32 traveling to or from the location of the farm work, if the
33 licensee resides on a farm or is employed for compensation on
34 a farm in this state. If employed, the licensee's parent or
35 guardian must provide consent pursuant to subsection 2.>

- 2 10. Page 6, line 1, by striking <or work shift,> and
3 inserting <work shift, farm work, or farm-related work,>
- 4 11. Page 6, line 21, after <employment> by inserting <or
5 location for farm work or farm-related work>
- 6 12. Page 6, line 22, by striking <a written statement> and
7 inserting <written consent>
- 8 13. Page 7, after line 4 by inserting:
9 <c. If the applicant receives competent private instruction,
10 the certification must be made by the applicant's primary
11 instructor.>
- 12 14. Page 7, after line 29 by inserting:
13 <a. "Competent private instruction" means as defined in
14 section 299A.1.
15 b. "Farm-related work" means work at a property suitable for
16 farming that is owned by the licensee's parents, guardians, or
17 employer.
18 c. "Independent private instruction" means as defined in
19 section 299A.1.>
- 20 15. Page 7, line 30, by striking <a.> and inserting <d.>
- 21 16. Page 7, line 33, by striking <employer.> and inserting
22 <employer unless the person is employed for purposes of farm
23 work or farm-related work.>

- 25 18. Page 8, line 4, by striking <c.> and inserting <f.>
