9 ~~offer of a coaching position by a school or a consortium of~~
10 ~~schools, but who has not completed the coursework required~~
11 ~~for a coaching authorization as specified in paragraph "a".~~
12 ~~A transitional coaching authorization is valid for not more~~
13 ~~than one year, shall not be renewed, and is valid only in~~
14 ~~the school or consortium of schools making the offer of the~~

4 to how use an automated external defibrillator.

5 (2) (a) A transitional coaching authorization shall expire
6 one year after the date of issuance.

7 (b) A transitional coaching authorization shall not be
8 renewed.

9 (3) The board shall allow an individual who holds a
10 transitional coaching authorization to convert the transitional
11 coaching authorization to a coaching authorization if the
12 individual does any of the following:

13 (a) Successfully completes the requirements established in
14 paragraph "a".

15 (b) Successfully completes the fundamentals of coaching
16 course created by the national federation of state high school
17 associations.

18 Sec. 2. APPLICABILITY. This Act applies transitional
19 coaching authorizations issued by the board of educational
20 examiners pursuant to section 256.165 on or after July 1,
21 2027.>
