1 Amend the amendment, H-8491, to House File 2800, as follows:

2 1. Page 35, after line 31 by inserting:

3 DIVISION \_\_\_\_

4 GADSDEN FLAG SPECIAL REGISTRATION PLATES

5 Sec. \_\_\_\_ . Section 321.34, Code 2026, is amended by adding  
6 the following new subsection:

7 NEW SUBSECTION. 11E. *Gadsden flag plates.*

8 a. Upon application and payment of the proper fees, the  
9 director may issue Gadsden flag plates to the owner of a  
10 motor vehicle subject to registration under section 321.109,  
11 subsection 1, autocycle, motor truck, motor home, multipurpose  
12 vehicle, motorcycle, trailer, or travel trailer.

13 b. Gadsden flag plates shall be designed by the department.  
14 The background shall be yellow at the top and bottom, with the  
15 color fading into white in the center. The plate's numbers  
16 and letters shall be black. The left side of the plate shall  
17 depict a black and white rattlesnake coiled on green grass.  
18 The image depicting the coiled rattlesnake shall be at least  
19 three inches tall and two inches wide. The phrase "Don't Tread  
20 on Me" shall appear at the bottom of the plate.

21 c. The special Gadsden flag fee for letter-number designated  
22 Gadsden flag plates is fifty dollars. An applicant may obtain  
23 personalized Gadsden flag plates upon payment of the fee for  
24 personalized plates as provided in subsection 5, which is in  
25 addition to the special Gadsden flag fee. Personalized plates  
26 authorized by this subsection shall be limited to no more  
27 than five numerals, letters, or combinations of numerals and  
28 letters.

29 d. The fees collected by the director under this subsection  
30 shall be paid monthly to the treasurer of state and deposited  
31 in the road use tax fund. Notwithstanding section 8.33, moneys  
32 appropriated under this subsection shall not revert to the  
33 general fund of the state.

34 e. Upon receipt of the special registration plates, the  
35 applicant shall surrender the current registration plates to

1 the county treasurer. The county treasurer shall validate  
2 the special registration plates in the same manner as regular  
3 registration plates are validated under this section. The  
4 annual special Gadsden flag fee for letter-number designated  
5 plates is fifty dollars which shall be paid in addition to  
6 the regular annual registration fee. The annual fee for  
7 personalized Gadsden flag plates is five dollars which shall be  
8 paid in addition to the annual special Gadsden flag fee and the  
9 regular annual registration fee. The annual special Gadsden  
10 flag fee shall be credited as provided under paragraph `d`.  
11 *f.* The department shall not condition the issuance of  
12 Gadsden flag plates on the receipt of any number of orders for  
13 Gadsden flag plates.>  
14 2. Page 37, line 10, after <eligibility,> by inserting  
15 <Gadsden flag special registration plates and fees,>  
16 3. By renumbering as necessary.
