#### **Procedural Business**

Senator Brown convened the regular, statutory meeting of the Administrative Rules Review Committee (ARRC) at 9:05 a.m. on Tuesday, July 19, 2022, in Room 116, State Capitol, Des Moines, Iowa. ## VETERANS AFFAIRS, IOWA DEPARTMENT OF

Committee members asked how much money is in the veterans trust fund (fund) at the end of each fiscal year. Ms. Miller stated there has been no money remaining in the fund at the end of the previous three fiscal years. She added that she has had to access the interest earned on moneys in the fund to pay amounts in excess of what is available in the fund to bridge the period until July 1 when the annual transfer and appropriation of \$500,000 from the lottery fund occurs. Members asked what the funding sources are for the money in the fund at the beginning of each fiscal year. Ms. Miller responded that the sources include donations and the annual \$500,000 appropriation, and that an income tax checkoff had also previously been a source of funds. Members asked the dollar amount of the department's annual expenditures from the fund. She responded that for fiscal year 2021, it was \$800,000. Members asked if that amount was for the fiscal year during which the department had lifted the \$20,000 maximum income eligibility threshold. She responded affirmatively and stated that approximately \$600,000 had been spent in the fiscal year prior to the income eligibility threshold being lifted. Members commented that the fund is underfunded. Members asked if the department maintains a waitlist, and Ms. Miller stated that the department does when necessary.

## IOWA PUBLIC INFORMATION BOARD

ARC 6360C (NOIA), Complaints; Contested Case Withdrawals; Public Records, Chs. 2, 4, 11

In response to Ms. Johnson indicating that she anticipated the board would not move forward with its proposed new chapter of rules relating to public records requests, but would pursue the other amendments contained in the rulemaking later in the year, committee members asked for clarification regarding the board's plans for the rulemaking and stated that adopting the rulemaking but excluding the new chapter of rules may exceed the scope of the notice of intended action. Ms. Johnson explained that the board would consider what action to take at a board meeting in August, that the board has multiple procedure options to not move forward with the rulemaking, and that the board is inclined to start over with a new rulemaking including only the amendments other than the new chapter. She also noted that the board membership has seen significant turnover. Members urged the board to start over with a new rulemaking and stated that the language on social media in particular is problematic, especially for cities with few staff available to monitor social media.

#### EDUCATIONAL EXAMINERS BOARD

Committee members requested clarification on the current status of these rulemakings. Ms. Proesch explained that these rulemakings resulted from a double-barreled emergency rulemaking process and that the notice of intended action is still pending. The board is reviewing the language of vetoed 2022 Iowa Acts, House File 2493, and will modify the noticed language on adoption to more closely align with the language of the bill. She provided a handout containing language the board is considering.

Mr. Dave Daughton, speaking on behalf of Rural School Advocates of Iowa and School Administrators of Iowa, expressed support for the new language being considered by the board and urged the committee to ensure it is adopted so that schools can utilize paraeducators as provided in the rules.

Ms. Melissa Petersen, speaking on behalf of the Iowa State Education Association, expressed support for the new language and noted that stakeholders registered on House File 2493 were all registered in support.

Ms. Margaret Buckton, speaking on behalf of Rural School Advocates of Iowa and the Urban Education Network of Iowa, explained that teacher shortages exist in both urban and rural settings and stated that the waiver process provided for in the new language is a good way for the board to gather data on teacher shortages. She also stated that the provision in the new language regarding compensation should not be addressed by rule, but should instead be addressed by statute. No action taken on ARC 6228C or ARC 6229C.
