## **BULLETINS NEEDED FOR THIS MEETING: 7/13/22, 7/27/22**

#### **Procedural Business**

Senator Brown convened the regular, statutory meeting of the Administrative Rules Review Committee (ARRC) at 9:05 a.m. on Tuesday, August 9, 2022, in Room 116, State Capitol, Des Moines, Iowa. Mr. Ewing explained that due to a system update in the Iowa Communications Network (ICN), the process for members to participate via the ICN has changed. The minutes of the July 19, 2022, meeting were approved. The next meeting was scheduled for Tuesday, September 13, at 9 a.m. The meeting was adjourned at 10:25 a.m.

## **Fiscal Overview**

Mr. Chris Ubben, Fiscal Legislative Analyst, presented the LSA fiscal report. Committee members asked if most health insurance policies and Medicaid cover the cost of newborn screening as provided under ARC 6432C and how the cost is covered if it is not covered by insurance or Medicaid. Mr. Ubben explained that it varies whether and to what extent screening is covered by insurance, and he would investigate whether screening is covered under Medicaid. He noted that there are other programs available to help families who cannot cover the cost themselves. He also noted that the screening is voluntary.

Rulemaking type is indicated in parentheses following the ARC number. The acronyms have the following meanings: Notice of Intended Action (NOIA), Amended Notice of Intended Action (ANOIA), Notice of Termination (NOT), Adopted and Filed Emergency (AFE), Filed Emergency After Notice (FEAN), and Adopted and Filed (AF).

### **SECRETARY OF STATE**

ARC 6414C (ANOIA), Proposed Constitutional Amendment—Right to Keep and Bear Arms, Rule 21.200(4) Committee members asked why August 12 was selected for the public hearing. Members stated that because the date was just now being made public, it only gave the public a few days notice. Ms. Widen responded that August 12 is 30 days from the date that the summary was first published in the Iowa Administrative Bulletin and noted that the Secretary of State (SOS) is only required to provide 20 days notice. She further stated that the deadline for the SOS to certify information to the counties is approaching and that limits the SOS's flexibility. Members asked if the public could request another public hearing. Ms. Widen stated that it is her understanding that such a request is not possible. Members asked how the SOS defines strict scrutiny. Members stated that many legislators needed a lawyer to explain the term, and expressed concern that members of the public will not understand what it means, or the potential ramifications. She responded that if a constituent contacts the SOS with questions they would be encouraged to reach out to one of the advocacy groups working in the state to educate the public on the constitutional amendment. She further responded that the role of the SOS is to prepare a summary of the constitutional amendment — it is a summary and not an explanation. Members asked if it is the role of the Iowa Supreme Court to define the term. Ms. Widen reiterated that the role of the SOS is to prepare a summary of the language in the proposed amendment.

Ms. Traci Kennedy, a volunteer with Moms Demand Action for Gun Sense in America (Moms Demand Action) stated that the summary is brief, vague, broad, and is a disservice to voters. She stated that the summary is the only language that many members of the public will see related to the proposed constitutional amendment prior to voting. She stated that members of Moms Demand Action have voiced their concerns during consecutive legislative sessions, including concerns related to applying strict scrutiny to gun laws. She explained that Moms Demand Action works hard to make communities safer and the amendment limits the opportunity to exercise local democracy to solve problems. She noted that three states that have passed a similar amendment have seen an increase in gun violence, including Missouri, which has three times more gun violence than Iowa. Ms. Kennedy urged the committee to require the SOS to include additional explanation in its summary due to the complicated language in the proposed amendment. Ms. Widen responded that Iowa Code sections 49.44 and 52.25 require that every voter have access to the summary as well as to the entire language of the proposed constitutional amendment. She stated that both will be provided on the ballot if space allows, posted in the voting booth, and included with every mailed ballot.

Committee members stated that just because the SOS does not have to do something it does not mean he should not. Members stated that every month the committee receives a summary of each rule that explains the rule and is not just a copy of the text of the rule. Members stated that the SOS is not providing a service to constituents by copying and pasting the text of the proposed amendment. Members stated that they have received education on the strict scrutiny standard; however, the public has not and may not know what it means. Members stated that it is their job to make sure that the public is informed on these types of matters.

Committee members mentioned that there is some confusion and that the SOS's explanation is not a rule. The SOS must describe, in a very limited space, what the proposed constitutional amendment does. Members stated there are advocacy groups on both sides of the issue that can speak to voters, and the SOS is doing what he is required to do by law.

Mr. Brad Hartkopf, speaking on behalf of the Association of Business and Industry, expressed support for the rulemaking. He explained that he had worked with the secretary of state's office when the fees were initially increased in 2017 to facilitate technology modernization and it was understood at the time that the fees would be reduced once the modernization was complete.

Committee members asked why the department did not schedule a public hearing for this rulemaking. Ms. Freudenberg explained that the rulemaking was based in part on recommendations from a task force, that the department received comments during the legislative process, and that the department typically does not schedule a public hearing unless requested.

Committee members asked why the staff-to-child ratio was changed in a facility setting, but not an inhome setting. Ms. Freudenberg explained that in-home settings are based on the total number of children, not ratios.

Committee members asked why the jobs impact statement indicates that the rulemaking will have no impact on jobs given the criteria of Iowa Code section 17A.4B, when legislators were told during session that the underlying legislation was necessary as a workforce issue. Ms. Freudenberg explained that the new standards in the rulemaking are voluntary, and the department does not know how many facilities will adopt them. She stated that the LSA agreed with the department's analysis and that the department may have more information in six months. Members stated that it would be more accurate for the department to indicate that the jobs impact could not be calculated than to assert there would be no impact. She indicated the department would make a better effort on jobs impact statements going forward. Members asked the department to report the impact of the rulemaking to the committee after six months, and she stated the department would do so.
