#### **Procedural Business**

Senator Brown convened the regular, statutory meeting of the Administrative Rules Review Committee (ARRC) at 9 a.m. on Tuesday, October 11, 2022, in Room 116, State Capitol, Des Moines, Iowa. # **Fiscal Overview**

Ms. Maria Wagenhofer, Fiscal Legislative Analyst, presented the LSA fiscal report. Committee members asked if the Legislative Services Agency (LSA) would prepare new revenue projections following the adoption of ARC 6570C. She stated that the LSA would do so soon.

Committee members asked for clarification on how this rulemaking is different from a similar previous rulemaking. Ms. Johnson explained that a controversial provision from the previous rulemaking was not included in this rulemaking, which only includes minor changes to the board's rules. Members asked for more information about the content of the rulemaking relating to resolution of complaints. She explained that the board has never used the language being rescinded and does not have the authority to give orders as described in that language.

Mr. Rigdon explained many law enforcement agencies, particularly smaller ones, have been experiencing greater turnover, and some no longer have any officers that meet the current requirement. He noted that firearms and driving instructors are particularly important for law enforcement agencies. Reducing the requirement will reduce the number of waivers requested for the requirement. He noted that a new supervision requirement is included with the reduction. Members expressed concern about lowering the training requirement and suggested that increasing pay is a more effective solution for increased turnover. Members also expressed concern that this change was being done by rule rather than through legislation.

Committee members asked for clarification on what the 18-month period in the rulemaking entails. Mr. Rigdon explained that instructors, whether employed by the academy or employed elsewhere but providing instruction at the academy, need 18 months of prior field experience in order to begin the process of becoming certified as an instructor. Additional standards must be met to complete the certification.

Committee members asked what the requirements are to become an instructor in other states. Mr. Rigdon was unsure. Members requested additional information about the academy's reasoning for lowering the standards as well as standards used in other states. He agreed to provide such information. No action taken on ARC 6545C.

Committee members asked if there were any issues with the first elections using the board's new vendor. Mr. Helland explained that the elections went better than expected and the new system worked well, with 179 employers timely submitting employee lists, and one employer submitting late. Comments from labor and employers were overwhelmingly positive. He stated that many employers failed to upload a list at all. Members asked for more information on employers who did not upload lists. He explained that about 85 percent of education employers failed to upload a list, which he described as a growing trend over the years. He noted that failure to upload a list results in automatic recertification of a bargaining representative. He was unsure how many employers fail to do so because of technical issues and how many choose not to. He explained that some employers state that they are choosing not to upload a list. He further explained that at least one labor representative had stated that they would tell an employer not to upload a list.

# ARC 6569C (AF), Home Food Processing Establishments, Ch. 34

Committee members stated that the underlying legislation, 2022 Iowa Acts, House File 2431, contemplated two limits on home food processing: a revenue cap and on-premises consumption. Members asked if the rulemaking places other limits on home food processing. Ms. Hackel explained that it was the department's understanding that it was the intent of House File 2431 to set a distinction between food establishments governed by Iowa Code chapter 137F and home food processing establishments governed by Iowa Code chapter 137D. The department attempted to narrowly craft language governing that distinction. She explained the department's approach to the distinction, particularly in regard to made-to-order food, which she stated was within the department's authority under the legislation. Members stated that the rulemaking seemed to contain additional restrictions not provided in the legislation.

Committee members asked for clarification of the made-to-order exception, particularly in regard to bakeries. Ms. Hackel and Mr. Speltz explained that the made-to-order exception is intended more for

restaurant experiences where food is prepared and then picked up immediately. Mr. Speltz stated as an example that picking up a pie that was previously ordered would not be considered made to order, whereas picking up a hamburger and fries would be. Filing an order is not the relevant characteristic for the exception. Additional discussion occurred regarding applicability of the exception to take-and-bake pizzas as opposed to hot pizzas and its applicability to food requiring special refrigeration equipment. Members stated that the rulemaking is unclear. Mr. Speltz noted that meal kits are included in the exception.

Ms. Jessica Dunker, speaking on behalf of the Iowa Restaurant Association, expressed support for the rulemaking. She noted that restaurants are the largest buyers of homemade food. She explained differences between restaurants and home-based businesses, which she stated have a different value proposition. She also explained that restaurants, particularly rural ones, have low profit margins. She stated the rulemaking would encourage innovation and allow restaurants to continue to purchase goods from home-based businesses.
