Procedural Business

Representative Jones convened the regular, statutory meeting of the Administrative Rules Review Committee (ARRC) at 9 a.m. on Monday, March 13, 2023, in Room 116, State Capitol, Des Moines, Iowa. The minutes of the February 13, 2023, meeting were approved. The next meeting was scheduled for Monday, April 10, 2023, at 9 a.m. Committee members voted to approve the committee rules of procedure. He explained that while a tap is not a defined length of line, as a matter of practice it is a short transmission line between a franchise line and a substation. Members asked if the right of eminent domain applies to taps. He responded that if a company needed additional land rights and wanted the board to grant the company the right of eminent domain, the company would have to go through the amendment process and the usual procedure for contested case hearings. Committee members asked if Airbnbs and rental residential locations are required to apply for a license to sell or dispense electric fuel. Ms. Wulfsen explained that if an Airbnb is also used as the owner's primary residence for a majority of the year, a license is not required. Members asked how the electric fuel dispensed at a charging station is gauged. She responded that the department is working with the Department of Transportation (DOT) and the Iowa Department of Agriculture and Land Stewardship (IDALS) to answer that question. She stated it is her understanding that there is a piece of equipment that can be plugged into a charging station to gauge the amount of electric fuel that has been dispensed. Members asked if the department is making a prudent decision if the cost to implement the rulemaking is compared to the revenue generated. Ms. Wulfsen responded that is a value judgment she would leave to the committee to decide. Members asked the cost of the piece of equipment used to measure the amount of electric fuel dispensed. She responded that IDALS requested a \$50,000 appropriation but she is uncertain if that represents the total cost.

Committee members asked if individuals from the department utilize that piece of equipment to test all fuel charging stations in the state. Ms. Wulfsen responded that the department is currently in talks with the DOT and IDALS to determine how to assign that responsibility. Members stated that IDALS does not have enough people to conduct fuel testing and there is a bill this session that requires testing to occur every other year, rather than annually, due to the personnel shortage. Members asked how many charging stations there currently are in Iowa. Ms. Wulfsen responded that she will obtain that information from the DOT and provide it to the committee. Members expressed concern that the revenue generated will not be enough to cover the costs of implementing the program, and that the taxpayers who do not have electric vehicles will be forced to pay the difference. Members asked where the generated revenue will be deposited. Ms. Wulfsen responded that the revenue will be deposited into the road use tax fund. Members asked what fund would be used to cover a shortfall if enough revenue is not generated to cover the cost of the program. Ms. Wulfsen stated that she will find out and provide that information to the committee.

Members asked if it is considered an appropriate cause if an employer comes to a show cause hearing and states they did not submit a list because they do not think an election is necessary. He responded that the legislature delegated the authority to the board to execute Code chapter 20. He acknowledged that while the member's argument is valid, particularly for contract extensions, there is no other way to execute an election. He stated that if the board adopts a rule and an employer violates it, the employer has failed to uphold the requirements. Members asked if the rulemaking is adding an additional requirement to the law. He responded that there is no way to execute the law without that requirement. Members commented, in terms of the recertification notice, that they hoped the board will encourage voter participation. No action taken on ARC 6912C.
