## BOARD OF REGENTS SETS TUITION RATES FOR 2020-2021 ACADEMIC YEAR

**Meeting.** The Board of Regents held its regular meeting in a virtual format on June 4, 2020, and conducted the second reading of a proposal for tuition rates and mandatory student fees for the 2020-2021 academic year. The Board approved the proposal and also approved the allocation of mandatory fees and the Common and University/Program-Specific Fees.

**Tuition Rates and Mandatory Fees.** The proposal adopted by the Board included no change in tuition rates for resident and nonresident students compared to the 2019-2020 rates. Mandatory fees also remain static, with the exception of Iowa State University, where fees will be reduced by \$4. The following table shows the details of the adopted proposal.
