## BOARD OF REGENTS DISCUSSES 2023-2024 TUITION RATES — MAY 11, 2023

**Special Meeting.** The Board of Regents met at the Board of Regents Urbandale office on May 11, 2023, for the first reading of proposed 2023-2024 tuition and mandatory fees for the 2023-2024 academic year. The proposal provides for a 3.5% base tuition increase for Undergraduate Resident students across all three Regent Universities (\$305 at the University of Iowa, \$304 at Iowa State University, and \$285 at the University of Northern Iowa). The universities propose varying tuition increases for nonresident, graduate and professional students. The Board also proposed varying common and program specific fee increases.
