

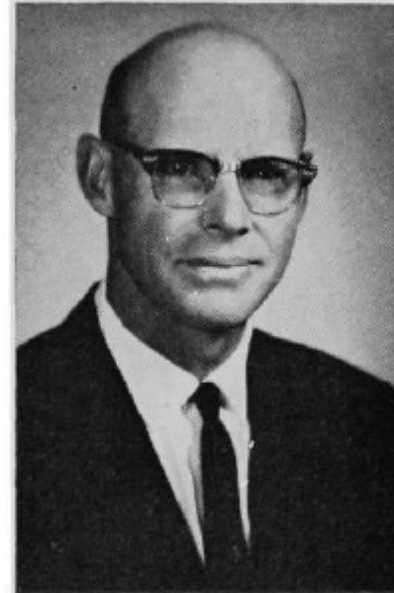


MOFFITT, Delmont, Mystic

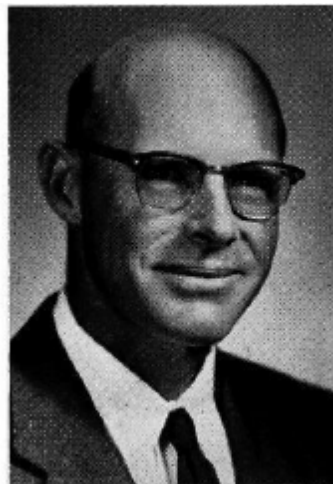
MOFFITT, Delmont, Mystic
