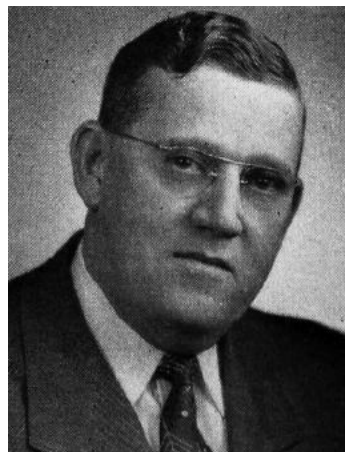




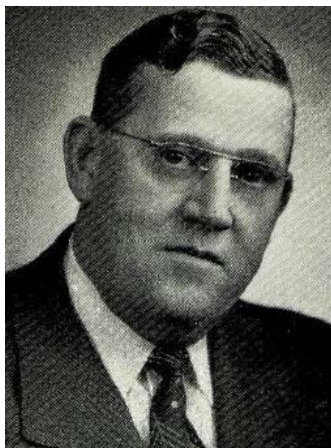
**COLBURN, Jay C., Harlan Shelby County
