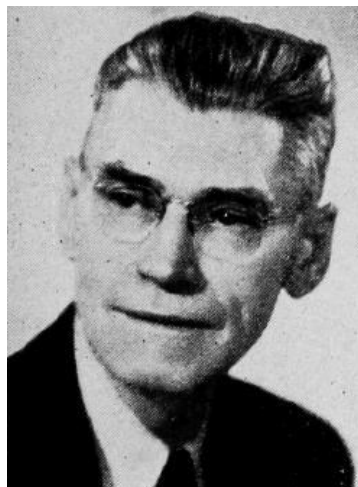


**PIEPER, Elmer, Waukon**
