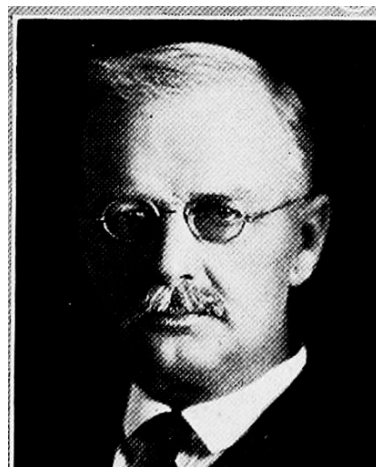




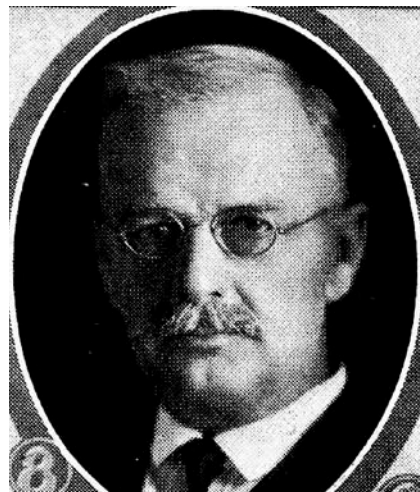

When twenty-one years of age he went to Adair county. Four years later he married Clara A. Martin, daughter of W. B. and Lucy E. Martin, of Greenfield. Mrs. Langfitt died on July 14, 1924. There are four surviving children, Harry M., of Marshalltown, Iowa, Bernice Louise, of Des Moines, Clara Mildred, and John N., Jr., of Greenfield. He lived several years in western Washington, but returned to Adair county in 1898, purchasing the family homestead on which he still resides.
