Re: Iowa Code section 8.7 Gifts and Bequests Report

Dear Division Director Lyons:

Iowa Code section 8.7 requires all gifts and bequests received by a department or accepted by the Governor on behalf of the State to be reported to the Iowa Ethics and Campaign Disclosure Board. The law requires the Board to then submit to the fiscal services division of the Legislative Services Agency a written report listing all gifts and bequests received during the previous calendar year with a value over \$1,000 and the purpose for each such gift or bequest. The submission shall also include a listing of all gifts and bequests received by a department from a person if the cumulative value of all gifts and bequests received by the department from the person during the previous calendar year exceeds \$1,000. Please find the attached list of all gifts reported by the Board that meet these criteria.
