Dear Mr. Roederer and Mr. Dickinson:

Pursuant to Iowa Code section 602.1301(2)(a), I hereby submit, on behalf of the Iowa Supreme Court, the FY2021 budget request for the Iowa Judicial Branch.

Investing in our communities is at the heart of the Iowa Judicial Branch FY 21 budget request. Through partnership with the legislative and executive branches, the judicial branch has advanced key initiatives that enhance services provided to Iowans. We are encouraged by this progress and are motivated to continue striving for improvement to deliver the justice Iowans deserve.

In FY 21, we have an opportunity to build upon Iowa's commitment to community-based justice. The path to becoming the nimble, innovative, responsive, and relevant organization that Iowans deserve from their government starts with investing in Iowa communities, and in Iowans. Iowans are the people we serve, but also who we are.

The judicial branch is the sum of 1,700 Iowans serving in all 99 counties. These judges and staff account for 96 percent of the judicial branch budget, with 92 percent of them operating at the trial court level. Investment in Iowans, and their communities, will enable the judicial branch to maximize our resources through technology and a physical presence in all 99 counties.

## Investing in Rural Communities

The judicial branch seeks to strengthen its ties with rural communities and to offer a full complement of services on a full-time basis. Staffing in clerk of court offices in 32 counties is below the recommended level of 2.5 staff. A minimum of 2.5 clerk positions is recommended in each courthouse to ensure safety, fiscal responsibility, full-time coverage, and full-service. Closely aligned with the need for achieving minimum staffing to deliver full-time full-service in every county is the need for adequate staffing to cover overall workload demands. According to the workload formula developed by the National Center for State Courts, 17 additional clerks are needed statewide to timely process the overall workload. As you can see, the minimum staffing number and the workload formula number exactly align. The funding of 17 positions will achieve both objectives.

Please note that our efforts to fully employ distributive work processing are at the heart of this initiative. Capitalizing on the capabilities of our electronic data management system (EDMS), we have launched two pilots where we are shifting the workload as needed to optimize utilization of staff across each judicial district. We are breaking down the silos of work that were specific to each county and sharing the overall work among all the counties in the district. So, while the workload of a particular county may not justify 2.5 positions, the overall workload of the district does and our plan is to equitably distribute it through EDMS to ensure full-utilization of all staff that are placed there.

We are also identifying where economies of scale exist by consolidating like types of work and creating specialized units to perform such responsibilities. For example, instead of having jury administration performed by one or two individuals in each county, the pilot district may have a small cohort handling the mailing and processing of all summonses for the entire judicial district. Again, by capitalizing on the benefits of EDMS, this team can be located in any county throughout the judicial district.

To support the vitality of rural courthouses and to serve all Iowans through timely processing of the workload, we are requesting 17 additional clerk staff.

## Investing in Human Capital – Existing Personnel

Iowans in all 99 counties benefit from the services provided by the 1,700 judicial branch judicial officers and employees. These judicial officers and employees are members of your communities. The education, experience and abilities of these individuals are the best assets of the judicial branch. Judicial officers and employees resolve disputes and provide justice to Iowans who need assistance in the over 700,000 cases filed every year. Reviewing our total compensation package, and keeping it current, will allow for greater organizational and individual success.

- 2.1% across the board increase mandated in employee contracts.
- 2.1% across the board increase for non-contract employees so they are treated the same as the contract employees.
- 1% step increase for contract and non-contract employees.

- 2.1% increase for judicial officers so that they receive the same across the board increase as other judicial branch employees.

#### Investing in Human Capital – New Personnel

According to the workload formulas developed by the National Center for State Courts, Iowans need 30 additional judges to process the current judicial branch workload. Twenty of the needed judicial officers are at the district associate court level. Our request for four district associate judges is part of a five-year plan to address this deficit. Please note that the current calculations do not factor in the recent code change that transfers minor guardianship jurisdiction from the district court to the district associate court. As such, the 20-judge deficit is likely going to increase when new caseload data becomes available at the end of next year.

- Add four district associate judges and support staff to address increasing workload. Add 12 staff (e.g. court reporters, judicial specialists, law clerks) to assist new district associate judges and existing judicial officers provide more timely resolution of Iowans' disputes.

#### Investing in Access to Justice

The Jury and Witness Fund pays for jurors' per diem, interpreters, and witness reimbursement. In order to provide translation of forms and higher quality services to Iowans who serve as interpreters and those who need interpreters, the judicial branch requests an increase to the Jury and Witness fund. This fund has not been increased in over 15 years.

The Iowa judicial branch values its continued partnership with Governor Reynolds and the legislature in providing the services that all Iowans deserve from their justice system.

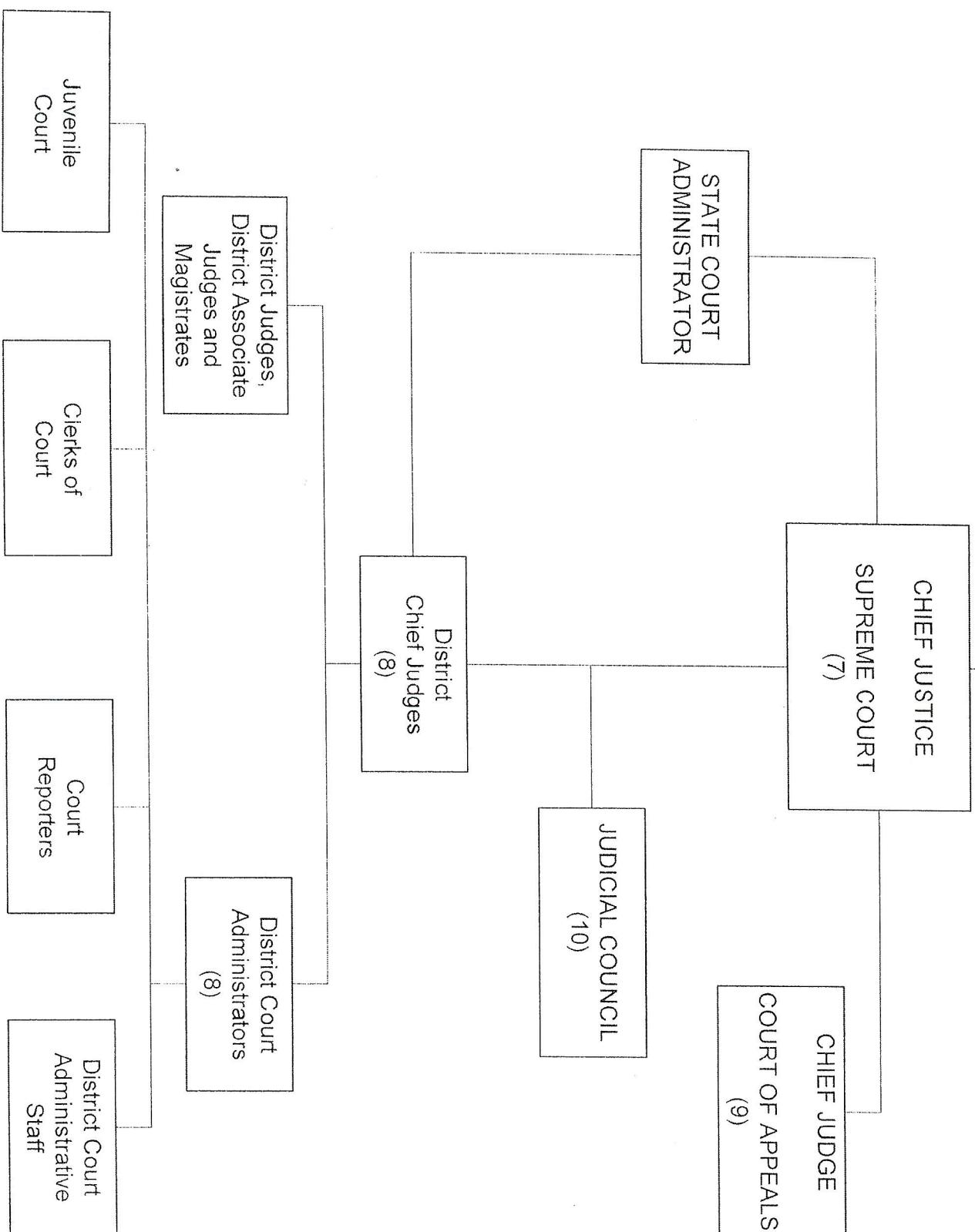
